With due respect I, Saraswati Mandal, W/O Late Amal Mandal. aged about 58 years residing at South Bharat Nagar, Girish Ghosh Sarani Road, near Fuleswari Bazar, ward number 24, Siliguri (M. Corp). Dist. Darjeeling, West Bengal, Pin. 734006, like to draw your kind attention to the following effect that, I stay in a rental house of Shri Subrata Roy Chowdhury from 2025 with my younger son Deep Mandal. On 30th March near about 9 a.m. my elder son came with dire consequences and attacked me with murder intentions. He beat me very badly here and there. He pressed me against the wall and throttle and tried to kill me. with the help of my younger son I rescued. For that reason I got a strong injury in my body parts and internal injury in my head. After this incident, when I came to the local police station to complain regarding the matter at approximately 1pm that time my younger son was alone at home. Sagar Mandal suddenly came and broke the main door and forcefully entered my home and attacked my younger son with murder intentions. He beat my younger son very badly here and there. For that reason I got a strong injury in my body parts and internal injury in my head. After

being a helpless woman I, therefore, request you please look into this matter as soon as possible and take proper legal action against these illegal activities and give relief to me.
