Sub : Prayer for lodge F I R against Raja for attempting murder and rape.

Respected Sir ,

With due respect and humble submission that I Ruth Samuel , w/o Samuel James residing at Door No 440 /4 Third Phase Airforce Station , Bagdogra , Dist : Darjeeling would like to state that Sepai Raja residing at Door No :- 440/3 , Ground floor Third Phase , Airforce Station , Bagdogra . On 21.04.2026 at about 6.20 pm when I came at our premises after evening walk , the accused raja parked his cycle inside the passage on the way of my walkable passage . Then I parked that cycle just beside because in last week that cycle obstruct my stomach. Due to this reason I parked that cycle in safe position. When I stepped on stair case Sepai Raja with his wife stayed in front the door of his house. Then Raja asked me why I touched his cycle? Then I told him that cycle obstruct me on the way to home , so I parked that cycle just beside , Is there is any problem arise for that reason. Then he came and loudly told me that he parked that cycle in walk able passage. Then Raja using abusing and slang languages upon me . Then I started video in my mobile phone . At that time he also told to his wife to bring the mobile phone from the room. Then he told me that " tera niche ka charbi Jada ho gaya , mai abhi kam karke dikhaye ga) Then I called to my husband and told him raja using slang and abusing languages upon me whether I slapped him by my chappal. Suddenly Raja hold his hand to my two shoulder and pushed me into the garage. Then I fallen down in the garage , He was upon me and hold my two hands (I kept my mobile phone in one hand) forcibly kicked multiple upon my lower person and try to attempt rape me. Then I screamed and when neighbours are came and he fled away from the spot and went to his house. I felt various pain inside my body in several parts . Then I came to stair case, at that time he invited me for sex with him inside the room. I split on his face. Then he came with Plastic Rod and beaten me here and there in our body . He also hold his hand to my neck and tried to murdered me. Then I hold his shirt on the collar. Then he called his wife . His wife came and forcible taken my phone , then started to beaten me with that plastic rod. This video captured by another Subedar.

So Sir I am mentally and physically harassed by him and want Justice.

So I therefore request you to lodge F I R against Raja & take necessary against him & punished him as early as possible.

I want justice.
