***Subject: Complaint regarding physical assault, life threats, and intimidation (F. I. R)**

Respected Sir/Madam,

I, Shri Bijay Barnwal, son of Late Mahadev Prasad Barnwal (who was a freedom fighter), having resident at Milanpally, Sukanta Sarani. I have been residing at my present address for the last 40 years. I am currently 72 years old. I have been running a small shop for the past 15 years for my livelihood. I am a widower and live alone.

I serve as a Booth President of the Bharatiya Janata Party (BJP). On the day of polling, when I went to my designated booth at Hindi High School as a reliever, Ward No. 25 Councillor Jayanta Saha saw me in front of news media personnel and instructed his workers to forcibly remove me from the booth. They attempted to physically assault me; however, I was rescued by one of our female party workers, Smt. Pratima Guha.

Thereafter, on 30.04.2026 at around 11:00 PM, a Trinamool Congress worker, Debasish Dey, came to my shop in an intoxicated condition. He used abusive language and threatened me that after 4th of May, he will catch me on the road, beat me, destroy my shop, and attack me as well as the workers of Ward No. 25 wherever he finds us.

Shortly thereafter, when I was about to close my shop, two individuals came and dragged me from the front of my shop gate. They assaulted me with punches and slaps and threatened to kill me. I became extremely terrified due to this incident. Even when a police van arrived at the spot, I was so frightened that I was unable to speak properly.

The next morning, I was having pain in different parts of my body and have been suffering from severe mental fear and trauma. It is also important to mention that about five days before the election, Councillor Jayanta Saha had called me to his office and issued a similar threat, stating that if I did not stop my political activities, I would face serious consequences later.

In light of the above mentioned incidents, I strongly apprehend that the said individuals can again attack me using their political influence.


Therefore, I humbly request you to kindly take my complaint seriously, out provide me with some adequate security, and take immediate legal action against the accused persons so that I can live safely and without fear.


