Subject: Complaint regarding house trespass, grievous hurt  
and criminal intimidation.

Respected Sir/Madam,  
I, Surya Bahadur Bista, Son of Parasu Ram Bista, presently  
residing as a tenant at Himali Sahid Nagar, Yalung Unisex  
fitness gym, Siliguri, Mahananda Bridge, 734001, Siliguri  
under landlord Mr. Kushal Tamang, respectfully submit  
this complaint regarding a serious incident that occurred  
on 30/04/2026 at around 9:30 - 10pm at our rented  
premises. (The tum tum driver name is Ram Singh).

On the said date, a person known to me as a "tum-tum"  
driver, whom I had booked for transportation from Champasari  
to my residence for Rupees 40. During the ride, a normal  
conversation took place and the driver asked for a  
glass of water and to which I agreed and later  
consumed alcohol with consent in a casual manner.  
And we had the conversation related to family. The driver

After some time, he stated that he would return  
with additional drinks and stay overnight after informing  
his wife. He handed a phone number 9749320215 to me.  
To call him in this phone number. Later, the Tom Tom  
driver returned around 8:30pm along with one unknown  
young male.

Initially, the conversation continued, however, the said  
young man insisted to drink, to which I refused. and  
the young man began to behave in a disrespectful  
and interfering manner and that young man was calling

ends to which, I asked him to leave the house  
but he refused and threatened me to call his associates  
and beat me up. Somehow, I managed to take him  
out of the gate.

However, after sometime, he returned along with  
approximately four other individuals, making a group.  
They forcibly entered my rented house when the  
door was open, forming an unlawful assembly  
with common intention.

The group were carrying dangerous objects such as  
a brick, a belt and knuckles and launched a violent  
attack upon me without any provocation. I was  
physically assaulted and pushed to the ground during the  
attack, I sustained serious injuries, including the loss of one  
tooth and injury to another tooth, along with bleeding and  
severe bodily pain.

When my elder son attempted to rescue me, he was  
pushed aside and threatened with further violence. The  
aggravated persons warned him not to intervene, stating that he  
would also be beaten up. Due to the severity  
of the attack, I suffered grievous injuries and was left

in a vulnerable condition. The incident created  
panic and fear among all present.

After the assault, the accused persons fled from the scene.  
While the landlord asked one of the tenants to lock  
the gate and as the taxi driver was still present inside  
the room and I did not have keys to open the gate, additional  
persons gathered outside the gate and continued issuing threats  
and disturbance.

ie Landlord was informed and the police were subsequently  
called to control the situation. It was discovered that one of  
the accused persons had damaged the property of another tenant.

Therefore, I humbly request you to:


Register an FIR against all the accused persons

Take strict legal action under relevant provision of Law.

Seek for the Justice.

I am ready to fully cooperate with the investigation
