Sir,

With due respect I am producing herewith one (01) arrested accused person namely Manoj Rajak (45 yrs./M) S/O Late Somar Rajak of Jabravitta, PS- NJP, Dist- Jalpaiguri under proper arrest memo and the following articles under seizure. The ground of arrest has duly been communicated with him.

- i) 14 (Fourteen) bottles of Himalayan Gold Country Spirit 60 UP containing 600 ml in each bottle in sealed condition which one bottle labeled as Sample marked as Exhibit A.

I SI Tanmoy Kundu presently attached with New Jalpaiguri PS, Siliguri Police Commissionerate under your kind control beg to state that today on 18/04/2026 during special raid duty received secret source information that person namely Manoj Rajak is selling liquor at at his residence i.e. Jabravitta, PS- NJP, Dist- Jalpaiguri to designed customer without any valid license for his illegal gain. Accordingly, I diarized the fact in General dairy vide PS GDE No: 1007 dated 18/04/2026 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, ASI Munna Ahmed C/453 Uttam Dey, C/1462 Sajan Tamang, VP 13 Jamirul Islam, and VP/08 Laxman Roy left for Jabravitta, PS- NJP, Dist- Jalpaiguri to work out the information in hand. We arrived at the Jabravitta, PS- NJP, Dist- Jalpaiguri and being identified by the source we apprehended above noted person. On search the above noted liquor recovered from his possession at his residence. On demand he failed to produce any documents/license in respect of store/sale the illicit liquor recovered from his possession. On being asked he disclosed his name and identity as Manoj Rajak (45 yrs. /M) S/O Late Somar Rajak of Jabravitta, PS- NJP, and Dist- Jalpaiguri and also disclosed that he is selling such liquor since long for his illegal gain. Accordingly, I seized the above noted liquor from his possession under proper seizure list in presence of local witnesses and arrested him under proper memo of arrest after observing all the formalities of arrest. The whole process of search and seizure was made in between 12.45 hrs to 13.05 hrs on 14/04/2026 under proper videography.

Hence, I pray to you considering the offence a specific case may kindly be started against the arrested accused person namely Manoj Rajak (45 yrs./M) S/O Late Somar Rajak of Jabravitta, PS- NJP, Dist- Jalpaiguri under proper section of law and arrange for its investigation. Seized articles were handed over the Makhana Officer with proper seizure list after maintaining all formalities.
