Sir,

In producing herewith one (01) arrested accused person namely Mannu Basfor (M/19) S/O Ganesh Basfor of D.S. Colony, near Kali Mandir, PS- NJP, Dist- Jalpaiguri under arrest with following articles under seizure. The ground of arrest has duly been communicated with him.

i) 14 (Fourteen) number of sealed Himalayan Gold Country Spirit each bottle containing 600 ml, out of which one bottle collected as sample.

In this regard I ASI Khagen Barman, presently attached with New Jalpaiguri PS, Siliguri Police Commissionerate under your kind control beg to state that today on 28/04/2026 during special raid duty received secret source information that one person namely Mannu Basfor is selling liquor at Kacha Goli near Netaji More, Ward No. 35, PS- NJP, Dist- Jalpaiguri to his designed customer without any valid license for his wrongful gain. Accordingly, I diarized the fact in General dairy vide PS GDE No: 1476, Dated 28/04/2026 and informed the fact to you. As per your kind direction and instruction myself along with VP 13 Jamirul Islam, and VP/08 Laxman Roy left for Kacha Goli, PS- NJP, Dist- Jalpaiguri to work out the information in hand. We arrived at the Kacha Goli, and being identified by the source we apprehended above noted person. On search the above noted liquor recovered from his possession at Kacha Goli. On demand he failed to produce any valid documents/license in respect of store/sale those illicit liquor. On being asked he disclosed his name and identity as Mannu Basfor (M/19) S/O Ganesh Basfor of D.S. Colony, near Kali Mandir, PS- NJP, and Dist- Jalpaiguri and also disclosed that he is selling such liquor since long for his wrongful gain. Accordingly, I seized the above noted liquor from his possession under proper seizure list in presence of local witnesses and arrested him under proper memo of arrest after observing all the formalities of arrest. Ground of Arrest was duly intimated to him in Hindi language. The whole process of search and seizure was made in between 12.55 p.m. to 01:10 p.m. on 28/04/2026 under proper videography.

Hence, I pray to you considering the offence a specific case may kindly be started against the arrested accused person namely Mannu Basfor (M/19) S/O Ganesh Basfor of D.S. Colony, near Kali Mandir, PS- NJP, Dist- Jalpaiguri under proper section of law and arrange for its investigation. Seized articles were handed over the Makhana Officer with proper seizure list after maintaining all formalities.
