Sir,

In producing herewith one (01) arrested accused person namely Kamal Roy (35) S/O Lt. Krishna Roy of D.S. Colony, PS- NJP, Dist- Jalpaiguri under arrest with following articles under seizure. The ground of arrest has duly been communicated with him.

- (1) 21 (twenty one) bottles of Himalayan Gold Country Spirit each bottle containing 600 ml
- (2) 17 (seventeen) bottles of 'Prakash' Country Spirit each bottle containing 600 ml and
- (3) 15 (Fifteen) bottles of Kingfisher, strong Beer, each bottle containing 650 ml

In this regard I SI Binup Mahato, presently attached with New Jalpaiguri PS, Siliguri Police Commissionerate under your kind control beg to state that today on 28/04/2026 during special raid duty received secret source information that one person namely Kamal Roy (35) S/O Lt. Krishna Roy of D.S. Colony, PS- NJP, Dist- Jalpaiguri is selling liquor to his designed customer near Netajee More, without any valid license for his wrongful gain. Accordingly, I diarized the fact in General dairy vide PS GDE No: 1502, Dated 28/04/2026 and reformed the fact to you. As per your kind direction and instruction myself along with SI Tanmay Kundu, VP/13 Jamirul Islam, and VP/08 Laxman Roy left for Netajee More, Ward No. - 35, PS- NJP, Dist- Jalpaiguri to work out the information in hand. We arrived at Netajee More, Ward No. - 35, and being identified by the source we apprehended above noted person. On search the above noted liquor recovered from his possession at Netajee More, Ward No. - 35. On demand he failed to produce any valid documents/license in respect of store/sale those illicit liquor. On being asked he disclosed his name and identity as Kamal Roy (35) S/O Lt. Krishna Roy of D.S. Colony, PS- NJP, Dist- Jalpaiguri and also disclosed that he is selling such liquor since long for his wrongful gain. Accordingly, I seized the above noted liquor from his possession under proper seizure list in presence of local witnesses and arrested him under proper memo of arrest after observing all the formalities of arrest. Ground of Arrest was duly intimated to him in Bengali language. The whole process of search and seizure was made in between 22:50 hrs to 3:05 hrs. on 28/04/2026 under proper videography.

Hence, I pray to you considering the offence a specific case may kindly be started against the arrested accused person namely Kamal Roy (35) S/O Lt. Krishna Roy of D.S. Colony, PS- NJP, Dist- Jalpaiguri under proper section of law and arrange for its investigation. Seized articles were handed over the Makhana Officer with proper seizure list after maintaining all formalities.
