Respected Sir / Madam,

I, Amrendra Kumar Sharma, S/o Gopal Kumar Sharma,  
R/o Tibet Road, Near Nyuma Office, Gangtok, Sikkim would  
like to report that:

On 29/04/2026, in between 0450-0510 hours, an accid-  
-ent occurred involving by elder brother Mr. Suraj Prakash  
Sharma, who was walking on pedestrian going to NJP Rail-  
way Station, at NJP Main Road, <sup>Breeze</sup> Bridge Hotel, Near Suryasen  
College lane (Road), opposite Saw Mill, NJP District. An  
A Tolo driver named Rohit Pasuan s/o Chandesar Pasuan  
R/o Rajendra Nagar, Cooli Para (Ph. No. 9332631393) helped  
my brother to Siliguri District Hospital for immediate  
medical treatment on finding my brother abandoned on the Road.

Upon receiving this information telephonically, I immedi-  
-ately rushed to hospital from Gangtok, Sikkim, where my  
brother had already been admitted.

As per the information provided by Mr Rohit Pasuan (Good  
Samaritan) and my brother, the accident occurred when  
a Tolo bearing ~~orange~~ green coloured registration plate with  
WB 73 2807, lost control and toppled onto my brother

causing injury to him. The said Tolo was of light color. After the incident, the driver of the said Tolo, along with approximately five (05) passengers, fled from the scene without providing any assistance to my brother leaving in pain and agony in immobile condition.

It is pertinent to mention that I was not present at the scene ~~as per~~ and the ~~facts~~ above mentioned facts were provided to me by my elder brother and Mr Rohit Pasuam (Good Samaritan).

I request you to kindly register an FIR under relevant legal provisions and take necessary action to trace the vehicle and take action against the driver involved in this hit and run case.

I am willing to cooperate fully with the investigation.

I am enclosing a copy of "Bed Head Ticket" issued by the Medical Officer, Siliguri District Hospital, along with Visitor's Pass of the same hospital.
