In producing herewith three (03) accused persons namely 1) Md. Samir (23 yrs./M), S/O-Md. Tafizul of Nipenia, Jyotiakali, PS - NJP, Dist. - Jalpaiguri 2) Raja Das (22 yrs./M), s/o Sibul Das of Deshbandhupara Colony, Nichpara, PS - Siliguri, Dist. - Darjeeling and 3) Md. Sarfaraj (23 yrs./M), s/o - Md. Mamta of Tulshipara, Khalai Bhaktari, PS - Matigara, Dist. - Darjeeling along with seized articles via:-

1. One iron made sword approx length 03 (Three) feet along with wooden handle.
2. One iron made Axe approx length 02 (Two) feet along with bamboo handle
3. One iron made Hammer approx length 01 (one) feet. along with bamboo handle
4. One Blue electric torch light
5. One Blue and Red colour Nylon rope.

I ASI Nilam Swarnakar of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 10/12 persons to the effect that on the night 03/05/2026 at 00-05 hrs received secret source of information to the effect that some miscreants with deadly weapons assembled in a dark place at Central Colony Railway Quarter under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 95 dt. 03/05/2026 . As per your kind direction myself along with ASI Munna Ahmed, C/1462 Sajan Tamang, C/453 Uttam Dey, CV - 306 Biswajit Roy, CV -824 Niru Kr Yadav left from PS for Central Colony Railway Quarter to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 00-15 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the Central Colony Railway Quarter under NJP PS, found a group of 10/12 persons assemble and gossiping in a dark place at that place. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the above noted three (03) persons and the others 07/09 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Central Colony Railway Quarter under NJP PS. Thereafter all the apprehended persons were searched and in presence of independent witness I conducted search and seizure. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in video graph as per provision of law . Accordingly I arrested the above noted accused persons u/s 35 BNSS after informing the ground of arrest and dully issue of memo of arrest. The whole seizure was made between 00-25 hrs to 00-35 hrs and the all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against 1) Md. Samir (23 yrs./M), S/O-Md. Tafizul of Nipenia, Jyotiakali, PS - NJP, Dist. - Jalpaiguri 2) Raja Das (22 yrs./M), s/o Sibul Das of Deshbandhupara Colony, Nichpara, PS - Siliguri, Dist. - Darjeeling and 3) Md. Sarfaraj (23 yrs./M), s/o - Md. Mamta of Tulshipara, Khalai Bhaktari, PS - Matigara, Dist. - Darjeeling and other 07/09 persons and arranged for its investigation.
