


Respected Sir,

I Sri Rajdeep Saha, son of Sri Khokan Saha, resident of Khalpara, Nehru Road, P.O. Siliguri Bazar, P.S. Siliguri, District. Darjeeling, would like to draw your kind attention that my wife Smt Paromita Saha, wife of Sri Rajdeep Saha, who is a active member of Bhartiya Janata Party, was engaged in election campaign and participated in various social media debates held for Siliguri constituency, and was being targeted by many oppositions during elections, that yesterday i.e. on 04.05.2026 one person namely Aslam and few others threatened me and my wife at college para at around 5.30 pm when both of us were going towards my matrimonial home situated at Ashrampara, Siliguri, suddenly the above named person namely Aslam along with one unknown miscreants blocked my car and threatened me and my wife saying "ONEK BORO BJP NETA HOE GECHIS TODER DUJON KEI GAYAB KORE DEBO" and flew away, we took the matter very lightly and thereafter both of us spent sometime to my matrimonial home and then came back to my parental home situated at khalpara.



That suddenly at late night at around 1.45 pm my wife received a call from her parental home that my father in law was feeling uncomfortable due to sudden high pressure, and after getting the news I decided to go to my matrimonial home alone keeping my wife home to look after my infant baby, that when I was going out from my home at khalpara, I saw few peoples in two wheelers are following me and suddenly all of them blocked my vehicle near Anandaloke Cinema Hall, S.F. Road, Siliguri and forcefully dragged me out from my vehicle, where I identified the above named same person namely Aslam and 16 other unknown miscreants who without any reason brutally assaulted me with fist and blows, and dashed my head in front of the vehicle saying "TUI SALA HINDUR BACHHA GULA TODER BONGSO SESH KORE FELBO AMRA", " TUI R TOR BOU ONEK BORO BJP NETA HOEGECHIS TOR BOU KE BOLBI AMAR NAAM ASLAM", "DANGIPARAR CHELE AMRA TULE NIA GIYE GAYAM KORE DEBO" . That I tried to escape myself but all of them altogether assaulted me and one person was taking video of the said incident where Aslam kept a RIVALVAR in my head and said "EKHONI SESH KORE DITE PARI SALA TODER" and thereafter all of them ran away and before leaving Aslam again threatened me saying "TOKE R TOR BOU KE KNODINO BJP KORTE JENO NA DEKHI" and told me that "TOKE PETANOR VIDEO TA SHARE KORBO R DEKHABO SOBAIKE HINDU DER KI BHABE PETATE HOY".

That after the aforesaid incident I informed my family members who recovered me from there and took me home, that after the said incident I was in deep trauma and fear and could not sleep for the whole night for unbearable pain, and thereafter today went to Siliguri District Hospital for check up.



and thereafter me and my family who is in deep fear decided to give a specific complaint against the above named miscreants.


Under the above circumstances me and my wife who are an BJP workers are in deep threat of our life and hence I am writing this complaint against Aslam and 16 other unkown miscreants for brutally assaulting me endangering my life and escalate communal violence in the city, and communal tensions, moreover all of the above named were carrying arms with them, hence I am requesting you to take a strictest again the above named persons as per law.
