Sir, I, Abhishek Agarwal, S/O Deepak Kumar Agarwal, running a business at Hill Cart Road, Siliguri under the name of 'The Jalpai Motor and Cycle Co' would like to report a distress incident that occurred today on 06.04.2026 at 07:55 pm outside my shop. I was preparing to close for the day and my scooter was parked in the Municipality designated parking area when another car was also being parked in the adjacent space.

The driver while parking his car hit my scooter causing it to fall from its stand. As soon as I realized and confronted the issue with the parking in-charge that led to a heated argument between me and the parking incharge. As he was responsible for parking the vehicles in the area in an ordered manner and when confronted the parking in-charge along with his associates surrounded me and physically assaulted me by hitting me on my face and ribs.

They also had a sharp object with them which they used to threaten and intimidate me giving an impression to take my life. Seeing this I had to leave my scooter and run away for my safety as they damaged my scooter also and finally threatened me by stating that they will come again tomorrow, making it seem like a life threat. Later, my scooter was recovered by my staff named Suman.

Currently, my father is out of station and I am very scared if I will be able to comfortably go to my workplace tomorrow and unsure if I can safely run my business and guarantee the safety of my customers in such an environment.

I FELT LIKE I WOULD HAVE HAD BEEN KILLED YESTERDAY IF PEOPLE WERE NOT THERE TO SAVE ME. THE INVOLVED PERSON ALSO TRIED TO KILL ME WITH A PAVER BLOCK THROWN ON THE ROADSIDE .LATER HE CHASED ME TO KILL ME WITH SOME SHARP OBJECT. I WAS SCARED OF MY LIFE AND SAFETY.

MD. NASEEM ALSO HIT OTHER PEOPLE INCLUDING MY STAFF, HIT MY SCOOTER AND ALSO DAMAGED MY SCOOTER BY KICKING AND THROWING.
