**Subject: Formal Complaint for Registration of FIR regarding Assault, Criminal Intimidation, and Public Nuisance**

Respected Sir,

I, **Mr. Navin Kumar Choudhary**, Manager of **Sri Narayani Indane Gas Agency**, having office at Patti Mill Compound, Burdwan Road, Behind Darjeeling Motors Hero Showroom under ward no. 4 of S.M.C, P.S. Siliguri, District: Darjeeling-734005. hereby submit this complaint seeking immediate registration of an FIR against the accused persons involved in a serious incident of **unprovoked assault, criminal intimidation, and public disturbance** that occurred at our agency premises today.

At approximately 4:00 PM, a young man (Gaurav Sharma) entered our gas agency premises **accompanied by his mother (Renu Sharma), who is a customer of our agency**. Upon being courteously asked by our employee regarding his concern, he **without any provocation or justification suddenly initiated a physical assault** on our employee (Mr. Vicky Choudhary).

The incident caused **panic and disruption** within the premises. In **self-defense**, our employee, **Mr. Vicky Choudhary**, attempted to protect himself, he was severely injured along with another employee named Baisakhi Das. Other employee members intervened solely to restrain the attacker and to de-escalate the situation; however, the said individual **continued his aggressive and violent behavior**.

During this time, the said woman (his mother), instead of pacifying the situation, **used abusive language and actively participated in the physical assault** along with her son.

During the course of the incident, **I was personally attacked by the said woman, who bit my hand, tore my shirt, and inflicted physical injuries resulting in bleeding**. I immediately sought medical treatment at **Siliguri District Hospital**, and the **medical examination report is enclosed herewith as evidence**.

Further aggravating the situation, the mother of the accused **created a public nuisance outside my office cum residence**, spreading **false and defamatory allegations** against me and my employee among passerby. Subsequently, the **father of the accused arrived along with several associates, and they used abusive,**

threatening, and intimidating language towards my family members and our employees, causing serious mental harassment and disturbance to our daily life.

This entire sequence of events reflects a deliberate act of violence, intimidation, defamation, and disruption of public order, which cannot be tolerated under any circumstances.

In view of the above, I respectfully request you to:

- Immediately register an FIR against the accused persons under appropriate sections of law
- Take strict and prompt legal action against all individuals involved
- Ensure safety and protection for me, my family members, and our employees
- Prevent any further harassment, intimidation, or escalation of the situation

I am fully prepared to cooperate with the investigation and will provide all necessary evidence, including medical reports and eyewitness accounts.

Kindly treat this matter with utmost urgency and seriousness.
