Subject: FIR regarding organized cattle theft, use of intoxicating substance, illegal transport of cattle, and offences under animal cruelty laws

Respected Sir/Madam,

I, Amit Kumar Gupta, resident of Tumbajote, Matigara, Siliguri, hereby lodge this First Information Report regarding a serious cognizable offence that occurred on 30/04/2026 at approximately 1:30 AM in Kholabakhtari under Matigara Police Station.

Incident details:

At the above-mentioned time, unknown persons arrived in a white Scorpio vehicle bearing registration number WB54K6872, with approximately four individuals. They unlawfully took away a black cow by allegedly using an intoxicating/noxious substance, thereby causing cruelty and harm to the animal and facilitating the theft. The vehicle was seen moving towards Khaprail.

There is CCTV footage available near the residence of Shri Ramshingh (former Panchayat member), who is also an eyewitness to the incident.

Such incidents of cattle theft are increasing day by day in the area. Recently, at Ektiasal, two suspected thieves were caught by locals and thrashed, resulting in one death and one serious injury. These incidents reflect a deteriorating law-and-order situation and the possibility of organized criminal activity.

Legal provisions attracted:

Offences relating to theft, administering stupefying substance, and common intention/conspiracy under the Bharatiya Nyaya Sanhita

Cruelty to animals under the Prevention of Cruelty to Animals Act, 1960

Violations concerning illegal handling/transport of cattle under the West Bengal Animal Slaughter Control Act, 1950

Prayer/Requests:

Kindly register this FIR immediately under appropriate sections of law.

Trace and seize vehicle WB54K6872 and identify/arrest all accused persons at the earliest.

Secure and collect CCTV footage from the location near Shri Ramshingh's residence and nearby areas.

Record statements of Shri Ramshingh and other witnesses.

Take urgent steps to recover the stolen cow.


Increase night patrolling and ensure coordination among all police stations under Siliguri Police Commissionerate.
