Subject: Complaint against Suranshu Tiwary for cheating and non-payment of loan amount of Rs. 4,00,000/-

Respected Sir,

I, Smt. Babli Paul Chowdhury, Wife of Late Kartick Paul Chowdhury, Resident of Sai Marg, P.O. & P.S. Pradhan Nagar, District Darjeeling, do hereby lodge this written complaint against one Suranshu Tiwary, Son of Sri Diwakar Tiwary, Resident of Bandri Jote, Dagapur, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, who is presently working as a teacher at Ila Paul Chowdhury School, Gulma Tea Estate, Sukna, P.S Pradhan Nagar, Dist. Darjeeling.

That on 26/11/2022, the aforesaid person namely Suranshu Tiwary came to me with my elder son with a request to pay him a sum of Rs. 2,00,000/- (Rupees Two Lakhs Only) and seeing the urgency said person borrowed a sum of Rs. 2,00,000/- from me through an account payee cheque bearing no. 000045 dated 27/11/2022, promising to return the same within three months. However, after the expiry of the said three-month period, he started stating that his financial condition was not good and that he was in need of some more money. Since he was my elder son's friend and had approached me in a very helpless situation, I decided to help him again by giving him another loan.

Thereafter, on 22/12/2023, I again paid him an additional sum of Rs. 1,50,000/- by way of a self cheque bearing no. 000076 dated 22/12/2023. After some days, on 06/01/2024, he further requested me for some more money stating that his wife was not well and that he required funds for medical purposes. Considering his request, I again paid him a further sum of Rs. 50,000/- in cash.

Thus, the total loan amount taken by him stands at Rs. 4,00,000/- (Rupees Four Lacs Only) from me.
