**Subject: F.I.R.**

Respected Sir,

I, **Smt. Hira Devi Singh**, Wife of Lakhi Singh, Resident of Debidanga, behind petrol Pump, P.S. Pradhan Nagar, Dist -Darjeeling West Bengal – 734003, beg to inform you that I am an old aged ailing person running me and my husband's livelihood form the rental income of my own house. My younger son namely Manoj Singh is taking care of us.

My elder son namely Ashok Singh and his wife namely Parbati Singh are for a long time torturing me and my husband both mental and physical and we being old aged person tolerated the same. We have already gifted landed property to my ender son and also given a cash of Rs. 12,50,000/- out of love and affection for their wellbeing with a hope that he will use the said landed property properly for their accommodation after constructing a house therein, but within 2 months of the said gift my elder son had sold the property to a third party for money. Being a parent, we could not throughout our elder son and allowed them to stay at our house. But the torture done by my elder son and his wife increased every day, inspite of maintaining us, they regularly started demanding money from me and my husband and if we refuse or unable to pay them, then they used filthy unspeakable language towards us and often assaulted us physically.

Furthermore, my elder son has also occupied a shop constructed by me for earning a livelihood. I have several times requested my ender son to return the possession of the said shop to us as he is not using it, but all in vain as he always used brute force against me and my husband. We have tried several times to sort out the matter with them, even taken the help of neighbors and local people but all in vain as they never listen to any reasoning.

On 05/05/2026, my elder son and his wife forcefully tortured and forcefully evicted the tenant on the first floor of our house and started to

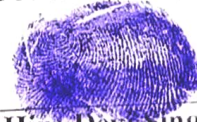
demolish the walls inside the house for his illegal gain. Today i.e. on 06/05/2026, at about 2 p.m., me and my husband went to my elder son and tried to reason with him and requested/begged him not to destroy the construction as the rent accumulated from the same is the only livelihood we have, as unfortunately enough my elder who we are expected to take care of us is not paying a single penny for our maintenance. But my elder son became aggressive and pushed/trashed my husband to the wall and even physically assaulted me and threatened us if we tried to stop him then we shall face consequences. My younger son Manoj Singh protested the said act of my elder son, due to which my elder son became furious and assaulted him as well with fist and blows.

My elder son namely Ashok Singh and his wife namely Parbati Singh, is torturing me on a daily basis since long and they are creating pressure upon us to give them more and more money otherwise we get assaulted physically on a daily basis. We tolerated the said torture with a hope that me elder son will come to his senses but his actions are getting aggressive ever passing day. Presetly, me and my husband are scared of our life and scared of them living at my house. Hence, I am requesting you being a senior citizen to make proper arrangement to evict them from our house and release the shop from their control, so that we can live safely and peacefully at our house.

Therefore, you are hereby requested to take proper legal action against Ashok Singh and his wife namely Parbati Singh and protect us from them by anyway possible.
