Subject: FIR regarding assault and loss of gold chain.

Respected Sir,

I, Nimesh Gurung, son of Nir Kumar Gurung resident of Navidanga,
Dist Darjeling would like to lodge a complaint regarding an
incident of assault and loss of my gold chain.

On 6-5-2026 at around 12:00 am while I was at Nivedita Rd
near Glenary's Pradhan Nagar to get my friend's scooter
from and near my office, few men charged towards me by
using foul language and started to abuse me and when
I confronted them, I was suddenly attacked by one known
man namely Sunny Lama and 7 other unknown persons.
During the incident I was physically hit and man handled.

In the course of this assault my gold chain was lost.
I believe that during the occurrence of the incident the
accused persons may have taken it since I cannot
find it around the place of the incident. I have searched
everywhere looking for it since the ~~first~~ day incident.
Later on I came to know one of the miscreant involved
was namely Abhijeet.


The details of the lost item are as follows:

- Item. Gold chain
- Approximate weight: 17 gram
- Estimate value 2,40,000 / approx.


I request you to kindly register my FIR under appropriate sections for assault and theft and take necessary legal action against the accused person. I am ready to co-operate fully in the investigation.

I kindly request you to take immediate steps to recover my lost property and ensure justice for physically assaulting me with beer bottles and other harmful items.
