In producing here with the three arrested accused persons namely (1) Prem Das 34 yrs S/O Indrajit Das R/O Krishna Nagar Colony, Near Thakurnagar Club, PS- Bhorer Ato, Dist- Jalpaiguri. (2) Bikash Khatai 23 yrs S/O Late Shibu Khatai, Kumar Toli, Durga Nagar, ward no- 04, PS- Siliguri, Dist- Darjeeling (3) MD Chattu @ Langra 29 yrs, S/O Late Md Amiruddin, R/O- Tulshi Nagar, Kholai Baktari, PS- Matigara, Dist- Darjeeling., (4) Md Jamshed 19 yrs S/O Late Md Amin R/O- Tulshi Nagar, Kholai Baktari, PS- Matigara, Dist- Darjeeling along with seizure articles and all connected papers.

I, ASI Debasish Das of Siliguri P.S. under Siliguri Police Commissionerate, do hereby lodged this written complaint against the above noted arrested accused persons that on 07.05.2026 at about 12.05 hrs I received a secret source information that about 08/10 anti socials being armed with deadly weapons assembled at South Bharat Nagar, near Jorapani Bridge, ward no- 24, under Siliguri PS for making preparation to commit dacoity in a house at South Bharat Nagar, Ward no- 24, under Siliguri PS. Accordingly the facts diarized in G.D (vide Siliguri PS GDE No- 260 Dated - 07/05/2026) and informed to IC Siliguri PS. As per his direction, I along with ASI Minhaj Al Kader, ASI Rabin Lama, Constable- 160 Soumen Sarkar left for South Bharat Nagar, ward no- 24, under Siliguri PS with investigation kit to verify the veracity about the information (vide GDE no- 261 Dated- 07.05.2026). At about 00.30 hrs I along with others reached at South Bharat Nagar, Ward no- 24, under Siliguri PS and kept our vehicle at considerable distance from the Jorapani Bridge, and I also looking for independent witnesses if any, but nobody found, due to night hours. Then, as per his guidance of source I along with others officers and force headed towards Jorapani Bridge, at South Bharat Nagar, Ward no- 24 under Siliguri PS and we saw a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away, but we managed to apprehend the above noted accused persons and others managed to flee away due to darkness. On interrogation they disclosed their Identity as noted above, and they also admitted that they along with 5/7 others assembled at the spot for making preparation to commit dacoity tonight in a house at South Bharat Nagar, area under Siliguri PS, accordingly I searched them in presence of witnesses and recovered 1) one (01) iron knife measuring approx Eight (08) inches recovered from the possession of Prem Das it was kept in back side of waist (2) One (1) Iron Rod measuring approx Twenty Eight (28) inches recovered from the possession of Bikash Khatai it was on his hand. (3) One (01) Iron rod measuring approx Seventeen (17) inches recovered from the possession of MD Chattu @ Langra, it was on his hand. (4) One (01) Nylon Rope measuring approx 16 feet in length from the possession of MD Jamshed it was on his hand which will be used for committing Dacoity tonight. Accordingly, I seized the above noted weapons as Alamat of this case from the exclusive and conscious possession of the accused persons, in presence of witnesses under proper seizure list duly signed by them (seizure and label on 07/05/2026 in between 00.55 to 01.35 hrs) with proper video graph. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in a house at South Bharat Nagar, Near Jorapani Bridge, ward no 24 PS- Siliguri, but others were managed to escape from the spot, accordingly I arrested them in presence of witnesses as per proper memo of arrest after informing ground of arrest.

Over the above noted facts, and circumstance it is a strong reason to believe that the arrested persons are assembled at South Bharat Nagar, Near Jorapani Bridge under Siliguri PS Dist- Darjeeling with deadly weapons for making preparation to commit dacoity in a house at South Bharat Nagar.

Therefore, I pray before you to start a specific case against the arrested accused persons namely 1) Prem Das 34 yrs S/O Indrajit Das R/O Krishna Nagar Colony, Near Thakurnagar Club, PS- Bhorer Alo, Dist- Jalpaiguri (2) Bikash Khati 23 yrs S/O Late Shibu Khati, Kumar Toli, Durga Nagar, ward no- 04, PS- Siiguri, Dist- Darjeeling (3) MD Chattu @ Langra 29 yrs, S/O Late Md Amiruddin, R/O- Tulshi Nagar, Kholai Baktari, PS- Matigara, Dist- Darjeeling., (4) Md Jamshed 19 yrs S/O Late Md Amin R/O- Tulshi Nagar, Kholai Baktari, PS- Matigara, Dist- Darjeeling & others 5/7 others, as per section of law and to cause its investigation.
