I, Miss Doma Tamang, Daughter of Dil Kumar Tamang, resident of Holdara, Teesta Valley Tea Garden, Darjeeling, Pin- 734226, would like to lodge this complaint against 1) Sri Gunga Munda, Son of Tepai Munda, 2) Sri Sanjay Munda, Son of Sri Gunga Munda, both are residents of Helapakri, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling, 3) Sri Bijay Kumar Sah, Son of Late Ram Khelwan Sah, resident of Salbari Hat, P.O.- Salbari, P.S.- Matigara, Dist.- Darjeeling, 4) Sri Rajiv Kumar Sah, Son of Jay Mangal Sah, resident of Patharghata, 2 Number More, Patharghata, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling, 5) Sri Vishant Raj Chhetri, Son of Bijay Raj Chhetri, resident of Salbari, Behind Union Bank of India, P.O.- Salbari, P.S.- Matigara, Dist.- Darjeeling, 6) Sri Sagar Chhetri, Son of Late Nand Kumar Chhetri, resident of Patang Fulbari, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling.

Previously I have purchased some quantum of land from Gunga Munda, in the year 2022, but in the month of January, Sanjay Munda, Son of Sri Gunga Munda has approached before me and told that his father sell more to intending purchaser, as his father is undergoing prolong illness and thus, I have agreed to purchased another quantum of land from said Gunga Munda and thus, I have paid a sum of Rs. 2,50,000/- (Rupees Two Lakh Fifty Thousand) only, as Advance money to Sanjay Munda and Sanjay Munda has executed one Money Receipt in this regard for selling of 1.5 Bigha land and total consideration money was fixed at Rs. 60,00,000/- (Rupees Sixty Lakh) only at Mouza- Khoplasi, under Matigara Police Station and he promised me to provide effective registration within 3 months.

But after lapse of three months, said Sanjay Munda is not giving me any registration of their 1.5 Bigha of land to me, nor he is returning me, the advance amount of Rs. 2,50,000/- and thus, on 05.04.2026, when I went to the house of said Sanjay Munda and Gunga Munda, at that time, the aforesaid persons were present there and when I asked what about the registration of my land, then said Sanjay Munda has flatly refused to give any effective registration of land and them, I demanded to returned

back my hard earned money , but he flatly refused to return back the money and the aforesaid persons have illegally asked me illicit sexual favour from me and also threatened me with dire consequences, if I lodge any complaint to police and touches my body illegally and without my consent and somehow, I was able to escape from their clutches.

In view of above facts and circumstances, I am humbly praying before you to kindly look into this matter and also take immediate action against them and also to register an F.I.R., against their illegal activities.
