Sir,

With due respect and humble submission I ASI Raju Prasad Yadav of Matigara P.S do hereby lodge this written complaint to the effect that today on 08/05/2026 I was deputed to perform special Mobile Van duty along with force, since 22:00 hrs to 08:00 hts. vide Matigara P.S. M.C.C. No. 1720/2026, Dated- 07.05.2026 and Matigara P.S. GDE No. 333, Dated- 07.05.2026. In course of said mobile van duty I received source information that one TATA Truck is standing at Matigara Bazar under Matigara P.S loaded with river bed material which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara P.S over phone and as per his kind direction myself along with forces rushed at Matigara Bazar under P.S.- Matigara and found one Tata Truck bearing Regn. No. WB73 G 5975 loaded with river bed materials standing at Matigara Bazar. On seeing the Police team the driver of the vehicle managed to flee away but somehow we apprehended him. On demand he could not produce any valid documents in support of said river bed materials. It is crystal clear that the driver/owner of the vehicle Tata Truck bearing Regn. No. WB73 G 5975 procured the loaded river bed materials from somewhere clandestinely and was proceeding to sale the same to their designated customer for their wrongful gain.

Finding no other alternatives, I seized the said vehicle Tata Truck bearing Regn. No. WB73 G 5975 loaded with river bed materials under proper Seizure List under coverage of Videography also brought the seized vehicle at P.S and arrested the driver namely, Tuleswar Barman (34 Yrs/Male), S/O. Sudhir Barman of Purba Rangia, P.O. New Rangia, P.S. Matigara Dist. Darjeeling. The seizure was made in between 08:10 hrs. to 08:35 hrs. on 08.05.2026.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver/ owner of the seized Tata Truck bearing Regn. No. WB73 G 5975 and arrange for its investigation.
