Sub: Complaint

Sir,

With due respect, I SI Pratap Basak of Bagdogra PS, SPC do hereby lodged a written complaint against one namely Dilip Kumar S/O- Rajesh Rai of Laxmi Narayan pur, PS- Tisiauta Dist-Baishali State- Bihar driver and owner of a vehicle (Pickup Van) bearing Reg No-BR 06 GG 3962 to the effect that on 05.05.2026 while performing K-35 van duty at about 12.40 hrs I received an information that one vehicle bearing Reg No-BR 06 GG 3962 loaded with total 13 (Thirteen) nos of cattle was coming from Naxalbari and passing through pocket road (Putimari road). Accordingly, I informed the matter to the O/C Bagdogra PS and as per his kind direction I along with force had been to Putimari to verify the veracity of information. After arrived at the spot on being identified by the source we managed to intercept the vehicle (Pickup Van) bearing Reg No-BR 06 GG 3962 at Putimari bridge under Bagdogra PS, SPC. Then I conducting searched around the vehicle. After through searching found total 13 (Thirteen) nos of cattle was loaded inside the said vehicle. I interrogated the apprehended driver of the vehicle. On interrogation he admitted that on 04.05.2026 he had loaded total 13 (Thirteen) nos of cattles from Naxalbari and had been proceeding with the vehicle bearing reg no. BR 06 GG 3962 loaded with 13 cattle for Sikkim. On demand he failed to produce any valid license/documents in respect of the cattles. It is clearly indicated that this 13 (Thirteen) nos of cattle were loaded in purpose of smuggling and illegally transport for wrongful gain. Accordingly, I arrested the apprehended accused person after issuing memo of arrest and informing him about the ground of arrest and recovered the 13 (Thirteen) nos of cattle and seized the vehicle bearing Reg No BR 06 GG 3962 along with 13 (Thirteen) nos of cattle under proper seizure list. The search and seizure was made in between 01.22 hrs and 01.27 hrs on 05.05.2026. The seized 13 (Thirteen) nos of cattle was handed over to the Chhot Maniramjote pond, Naxalbari, Dist- Darjeeling vide receipt no- 52, Dated- 05.05.2026.

I, therefore requested to you kindly registered a specific case under proper section of law against the driver and owner of the vehicle bearing Reg No- BR 06 GG 3962 namely Dilip Kumar S/O- Rajesh Rai of Laxmi Narayan pur, PS- Tisiauta Dist-Baishali State- Bihar and cause its investigation.
