I Md. Osman Son of Md. Sayeb, Secretary at Masjid-e-Bilal which
is situated at Jorepokhri, Faiz Nagar, P.S. NJP, Dist.: Jalpaiguri beg to state as
follows:



Md. Osman
1. That today at around 2:00 to 2:30 pm 1) Binoy Roy, 2) Subhash Bachhar ,
3) Sudip Debnath, 4) Bappi @ Chottu alongwith 5) Bishu 6) Deepak, 7)
Shekhar, 8) Rikki 9) Sourav 10) Atul along with 20 to 25 unknown men
forcefully broke open/entered the above mentioned Masjid-e-Bilal.
 2. That after forcefully entering the Masjid the above mentioned people
started damaging the Masjid property and when the Imam of the Masjid
obstructed the same the above mentioned people mercilessly assaulted the
Imam with fists and blows and kicks and also tried to kill him by holding
his hands and legs by four to six people and threatening to kill him by
throwing him down the terrace of the masjid.
 3. That their torture did not stop to just damaging the masjid building and
assaulting the Imam, they then broke speakers, mike etc through which
the Azan is to be given on daily basis. As they have problem with the
sound of the Azan so they purposely damaged the speaker and mike of
the Masjid so that no Azan could be given at the fixed timings.

4. That they also peed/urinated within the premises of the masjid and also on the terrace of the masjid hurting religious sentiments of the people as the masjid is considered as a sacred place where prayers are offered five times a day.
5. That they while chanting the slogans "Jai Sri Ram" climbed the masjid walls and went unto the terrace of the Masjid and have put the flag of the "Sri Ram" on the terrace of the masjid and from there they threatened the local people who are mostly Muslims and said that the day is very near when every masjid in the state will turn down to ashes just as the Babari Masjid.
6. That such incident is increasing day by day specially after the declaration of the West Bengal results and we fear that we being the minority community are under great danger. That there such incident clearly shows the direct attack on the worship place and on the Muslim minorities.

I therefore request you to take strict against the aforesaid culprits.
