SUB: FIR REGARDING ROAD ACCIDENT

Respected Sir,

I, Shreya Manjhi, daughter of Shri Barun Kr Majhi, residing at D.S Colony, Qtr No. 12/C, NJP, Post Office Bhaktinagar, Police Station New Jalpaiguri, PIN 734007, in the state of West Bengal, would like to state that I am writing to file a First-Information Report [FIR] regarding road accident that occurred on 10.04.2026.

Details of the accident:

Date of accident : 10.04.2026
Time of accident : At about 8.30 am.
Location of accident : Near Friends Union Club on the main
Road of NJP station
Offending vehicle : Registration no. WB12D7340, four Wheeler

Details of the accident:

That on 10.04.2026 my father was riding his Activa scooter being registration no. WB74AG8560 who was going to drop myself from our home to towards the Tinbatti More as from that day my class 12th exam had started, it was my first exam and the exam center was the Little Angels School situated at Tinbatti More and exam timing was 9 am., hence I was going to my exam center with my father who was riding the said scooter to drop myself but when we reach near friends union club my father following the traffic rules was crossing the road on moderate speed but suddenly offending vehicle bearing registration no. WB12D7340, four wheeler, maker Mahindra, with full speed without blowing horn was coming from Tinbatti More's side and going towards NJP railway station, the said vehicle by overtaking the other vehicle and

ignoring the speed breaker in full speed had suddenly hit us from our front side when we already reached to the left side of the road as a result of which we have fell down and a massive accident had been taken place due to the rash and negligent driving of the offending vehicle bearing registration no. WB12D7340 as such I had sustained severe injury and was hospitalized immediately and discharged from the hospital on 22.04.2026. That due to the severe injury sustained I could not appear for my class 12th examination which was scheduled from 10.04.2026 to 27.04.2026.

Injury Sustained:

- (i) Fracture in the right superior aspect of the sacral bone and right superior pubic Remus.
- (ii) Fracture in the right lateral aspect of the clavicle likely traumatic.

Damage to property Activa WB74AG8560:

- (i) Headlight.
- (ii) Meter cover.
- (iii) Front Mudguard.
- (iv) Other internal damages.

That due to injury sustained, I was hospitalized from 10.04.2026 to till 21.04.2026 and discharged from the hospital on 22.04.2026 hence I have been prevented to lodged a First Information Report [FIR] regarding the accident happened to myself and still I am in trauma but after feeling a little recovery from my injury I hereby lodging this complaint against the driver of the offending vehicle bearing registration no. WB12D7340 and would request you to kindly registered an FIR regarding this accident and investigate the matter further, I am available to cooperate fully with the investigation and provide any additional information that may be required.
