Dear Sir,

I, Pushkar Cowsay, son of Late B. B. Cowsay, residing at Agam, Singh Nagar, Panchanai, PO Pradhan Nagar, P.S. - Pradhan Nagar, Dist: Darjeeling, Siliguri would like to bring the following incident to your notice.

I am writing to report a fraudulent withdrawal of ₹ 86,271.98 amount from my SBI bank a/c no. 10231967505, Halimpara branch, Siliguri. The total 7 transactions have been made from the bank account. Total 5 transaction occurred at INDIA 1 ATM located at Darjeeling more Siliguri and the rest 2 transactions happened at the City Centre, Siliguri.

The incident occurred at/between 12:10pm - 1:00pm on 7<sup>th</sup> May, 2026.

I entered the "INDIA 1 ATM" located at Darjeeling more, Siliguri to withdraw cash from my debit card. I tried to check my balance initially it was successful but my debit card got stuck in the atm-machine. I tried my best to pull out the debit card but I couldn't.

In the meantime, somebody from behind offered to help and pressed few buttons but failed to retrieve the debit card.

The 2nd person asked me to also <sup>do</sup> did the same, he also 'hoaxed' me to dial the so called "Toll-free number" written on the wall "7602863813". I dialled the number, toll free person on call asked me to press 'cancel + the other below' button while the 2nd person was also inside the atm. The 2nd person inside the atm tried few steps, pressing the button pretending to help and after that he left the atm

The person on the call "hoaxed" me to dial the pincode, I dialled it while he was on call. It didnot work out, so he told me that he would find an engineer for me. He told me that <sup>there</sup> was no engineer available asked asked me to come at 4 p.m.

I disagreed stating that it would be very late for me to wait. He said me to wait for sometime and then told me he would help but I have to immediately visit the branch office which he told me was at "check-post" area. He asked me to hurry up and reach the location as soon as possible. I dialled him when I reached that location but he didnot pick or was busy. He called me back to inform that the engineer went out for work and told me to come tomorrow. After that I came back to the same atm location but I didnot find my locked atm/debit card in the machine anymore.

I got a call again and when I told him about my missing debit card he told me the card went inside the machine and told me to come back tomorrow. The scanner has made about 7 transactions in between all these incidents.

I have attached few details along with this application for your reference.

I request you to kindly register an FIR in this matter. I am a senior citizen my hard earned pension / money has been taken away. I believe a quick action will be taken and justice will be served.
