Sir,
With due respect, I am producing herewith one accused person namely Manohar Roy (50 yrs) S/O Late Jogeswar Roy of Thakkar, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following seized articles viz :- (i) 01 one paper made cartoon containing 30 bottles of India made Liquor (KACHI) each bottle containing 300 ml i,e total (30 x 300 ml = 09 ltrs) - Marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and Marked as exhibit "A1" (ii) 01 one paper made cartoon containing 30 bottles of India made Liquor (KACHI) each bottle containing 300 ml i,e total (30 x 300 ml = 09 ltrs) - Marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and Marked as exhibit "B1" (iii) 01 one paper made cartoon containing 20 bottles of 60 up Himalayan Gold India Made liquor each bottle containing 600 ml i,e total (20 x 600 ml = 12 ltrs) - Marked as Exhibit "C" out of which one bottle of the same taken as sample for examination and Marked as exhibit "C1" and (iv) one Scooty (ACCESS-125) (Sujuki) having Registration No WB/74/BJ/1244 with its key marked as Exhibit "D".

I ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above noted arrested accused person namely Manohar Roy (50 yrs) S/O Late Jogeswar Roy of Thakkar, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 09.05.26 at 22.10 hrs I received a specific secret source information that one person is selling illicit liquor illegally at Lal Diesel Ground, Lal Diesel Colony under PS Pradhan Nagar, Dist. Darjeeling without any valid documents. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No. 484 dated 09.05.26 and informed the matter to you. As per your kind order and direction, I along with SI Goutam Mallik of SB, SPC, ASI Bikash Roy and force all of Pradhan Nagar PS left for Lal Diesel Colony under PS- Pradhan Nagar, Dist. Darjeeling by Govt vehicle with investigation kit to verify the veracity of the information. On the way to Lal Diesel Colony, I informed one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Gokhel Road, Arabinda Pally, PS- Siliguri Dist. Darjeeling and requested him to come to Lal Diesel colony with his camera to videograph the entire process of search and seizure if required. At around 22.25 hrs we arrived at Lal Diesel Colony and contacted with my source and from a considerable distance being pointed by the source we noticed that one person was engaged in selling liquor from a scooty to his customers. Accordingly, we cordoned the place from every corner with due care and caution and managed to apprehend him with a scooty having Registration number WB/74/BJ/1244 in his possession. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation the detained person disclosed his identity as noted above. On search the scooter having registration number WB/74/BJ/1244 I recovered the above noted articles which were kept in the leg passage of the scooty. On demand he failed to produce any documents in respect liquor recovered from his possession. During local enquiry it could be revealed that the person namely Manohar Roy (50 yrs) S/O Late Jogeswar Roy of Thakkar, PS- Pradhan Nagar, Dist. Darjeeling is running such type of illegal business of selling illicit liquor without any valid documents for his wrongful gain. As the accused person namely Manohar Roy (50 yrs) S/O Late Jogeswar Roy of Thakkar, PS- Pradhan Nagar, Dist. Darjeeling has violated the norms of Bengal Excise Act, further I seized the above noted articles under proper seizure list in presence of witnesses and arrested him under proper memo of arrest and observing all the formalities of arrest. I also issued copy of memo of arrest and copy of ground of his arrest in written to him and brought to Pradhan Nagar PS for further investigation. The entire process of search and seizure was made under the coverage of video graphs in between 22.55 hrs to 23:20 hrs at the spot as per norms of BNSS. I also informed his son namely Pritam Roy regarding arrest of his father Manohar Roy over mobile phone having mobile no 9134251556 from the spot and also informed that the said accused will be forwarded before Ld Court on 10.05.26 morning at around 11.00 hrs. .

Therefore, I pray before your good self that a specific case may kindly be initiated against the accused person namely Manohar Roy (50 yrs) S/O Late Jogeswar Roy of Thakkar, PS- Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
