Sir,

With due regard, this is to bring to your notice
that I, Dr Prantika Mandal, a citizen of India
and a Dental Surgeon (WBDS) of North Bengal Dental
College and Hospital was harassed to and humiliated
and verbally abused by a biker [Vehicle No. WB73
LO274] near the Noulaghat Bridge today (07.05.2026), Thursday
around 10:45 to 11:00 am.

The biker rode beside me and suddenly came
in front of my car and blocked the road.
He came down from his bike, asked me to
lower the glass of my car. He then
started abusing me and threatening me with
abusive words. He ^{also} accused me of driving
my car over his foot and with immense
rage, he shouted at me and ordered me
to come out of the car, and He then ~~is~~ told
me that being a woman, I should hold his
feet and apologize to him. He took my
video and photo without my consent and
told me he will defame me and make me
viral in the social media.

I am feeling intensely horrified, threatened,

and humiliated at this unexpected incident.
This road where this humiliating incident
took place is my daily road to my
work place [North Bengal Dental College & Hospital].

I am feeling insecure that this might
be repeated again and they can risk
my basic wellbeing and life.

I hereby wish you kind consideration
for necessary action regarding this
sad and humiliating incident which
has threatened impact on the basic dignity
& and even life of a general person like
me.
