Respected Sir,

I would like to lodge an FIR regarding a serious assault on my son Ansh Aryan aged 21 yrs ^{today} On the way back home near Kalibari Temple, Gate Bazar around 1.30PM, a boy named Md. Arman along with one Vivek Singh stopped my son and brutally attacked him. They assaulted him physically and also hit him with a sharp object/weapon on his head and back with the intention to kill him.

Due to the attack, my son suffered severe injuries on his head and back. He has sustainable fractures and multiple serious injuries all over his body. His condition became critical and he has been admitted in STAR HOSPITAL, Tinbati more for treatment.

This was a planned and life-threatening attack. Therefore, I request you to kindly register an FIR immediately against the accused person Md Arman and Vivek Singh, and take strict legal action against them at the earliest.
