Sub: Lodging of FIR regarding unlawful trespass, mischief,
Dacoity, damage of property and criminal intimidation.

Sir,

I, Md Javed Akhtar, S/o Basimuddin, resident of
Barbari, P.O. Sahudangi, P.S. New Jalpaiguri, District
Jalpaiguri, respectfully submit the following facts for
your kind information and necessary legal action:

That on the night of 10.05.2026 at about 2:10 A.M., the
accused person namely: ① Akash Sahni, S/o Binod Sahni
② Bablu Sahani, S/o Kapil Sahani, along with several
associates, unlawfully entered into our Masjid premises
and surrounding area. That the accused persons forcibly
trespassed into the premises, created disturbance, and
caused extensive damage to the articles and property,
including furniture and other belongings kept inside
the Masjid. That they broke and damaged
valuable materials, and created panic among the

local residents. They also broke the donation box and took all the money which is around 26,000/- (Twenty six thousand). That when we protested against such illegal acts, the accused persons threatened us with deadly weapon and intimidated us, creating fear and insecurity in the locality. That the entire incident was intentional, unlawful and done with common intention to disturb public peace and damage property.

Therefore, I humbly request you to kindly; treat this petition as an FIR, register a case against the above mentioned accused persons under appropriate sections of laws relating to criminal trespass, mischief, doerity, damage property, unlawful assembly, and criminal intimidation and take necessary legal action against them in accordance with law.
