Sir,

I would like to draw your kind attention to the matter of illegal mining activities reportedly taking place in the River Balason, particularly in the areas of Dhimaljotea Area, Nayabasti Area, and M.M.Tarai under your jurisdiction.

As per verbal information received from local residents, it has come to notice that mining operations are being carried out repeatedly and allegedly without following proper legal procedures. Such activities not only violate existing regulations but also result in significant loss of government revenue and pose environmental risks to the river and surrounding areas and also change morphology of River Balason, which lead to massive erosion of River Bank.

In view of the above, I would request you to kindly look into the matter and take necessary action to ensure that proper procedures are enforced and the illegal mining activities are stopped at the earliest.
