Sub: Complaint

Sir,

With due respect, I ASI Binay Subba of Bagdogra PS, SPC do hereby lodged a written complaint against one namely Shahjahan Ali S/O- Lt. Habibar Rahman of Khayrabari, PO- Barpeta Road, PS- Barpeta Road, Dist- Barpeta State- Assam driver of a vehicle bearing Reg No-AS 01 UC 6739 to the effect that on 08.05.2026 while performing K-35 van duty at about 08.45 hrs I received information that one vehicle bearing Reg No- AS 01 UC 6739 loaded with total 15 (Fifteen) nos of Buffalos was coming from Naxalbari side. Accordingly, I informed the matter to the O/C Bagdogra PS and as per his direction I along with force had been to Panighata More to verify the veracity of information. After arrived at the spot on being identified by the source we managed to intercept the vehicle bearing Reg No- AS 01 UC 6739 at Panighata More under Bagdogra PS, SPC. Then I conducting searched around the vehicle. After through searching found total 15 (Fifteen) nos of Buffalos were loaded inside the said vehicle. I interrogated the apprehended driver of the vehicle. On interrogation he admitted that on 08.05.2026 he had loaded total 15 (Fifteen) nos of Buffalos from Bihar and had been proceeding with the vehicle bearing reg no. AS 01 UC 6739 loaded with 15 (Fifteen) nos of Buffalos for Assam. On demand he failed to produce any valid license/documents in respect of the Buffalos. It is clearly indicated that this 15 (Fifteen) nos of Buffalos were loaded in purpose of smuggling and illegally transport for wrongful gain. Accordingly, I arrested the apprehended accused person after issuing memo of arrest and informing him about the ground of arrest and recovered the 15 (Fifteen) nos of Buffalos and seized the vehicle bearing Reg No AS 01 UC 6739 along with 15 (Fifteen) nos of Buffalos under proper seizure list. The search and seizure was made in between 10.30 hrs and 10.45 hrs on 08.05.2026. The seized 15 (Fifteen) nos of Buffalos was handed over to the Halal pond, PS- Bagdogra, Dist- Darjeeling vide receipt no- 105, Dated- 08.05.2026.

I, therefore requested to you kindly registered a specific case under proper section of law against the driver of the vehicle bearing Reg No- AS 01 UC 6739 namely Shahjahan Ali S/O- Lt. Habibar Rahman of Khayrabari, PO- Barpeta Road, PS- Barpeta Road, Dist- Barpeta State- Assam and cause its investigation.
