Sir,

1. I, Prena Karjee of above mentioned address on 04 Jan 2026 evening at about 1730 hrs while riding my sister's scooter (Ms Karizma Rai) two wheeler with Regd No. WB 74 AR 3711 travelling back from my office located at Bagdogra and was heading to home in NH 31 towards Matigara. At that time near Gosairpur Petrol Pump a four wheeler Maruti Car Regd No WB 74 BQ 3681 hit me from side of my scooty and due to collision I fell on road and I was severely injured and my scooty got damaged. After that I took first aid and was taken to hospital for treatment.

2. I was under treatment from that time. Later, I got treated at Galaxy hospital and then for further treatment was done at Dr Chhang Super Speciality Hospital.
3. Due to the carelessness of the driver of said Maruti Car the accident happened resulting in breakage of my left hand and left leg.
4. I am still under bed rest and due to my treatment there was a delay in lodging complaint at your Police Station.
5. I hereby humbly request you to lodge an FIR against the driver so that such incident may be avoided further and justice may be provided to me.
