In producing herewith 05 (five) arrested accused persons namely (i) Md. Sharukh (M/29 Yrs.) S/O Lt. Md. Mukim of Coila Depo, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling, (ii) Md. Sahid (M/ 19 Yrs.) S/O Md. Hamid of Gowalapatty, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling , (iii) Md. Jahangir (M/27 Yrs) S/O Lt. Javed Ali of Tikiapara, Ward No. 28 of SMC, P.S- Siliguri, Dist.- Darjeeling, (iv) Bijay Barman (M/ 19 Yrs.) S/O Lt. Gautam Barman of Coila Depo, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling and (v) Aman Paswan (M/ 19 Yrs.) S/O Kumar Paswan of FCI Gate, Ward No. 35 of SMC, P.S- NJP, Dist.- Jalpaiguri along with the following seized articles under seizure as per seizure list :-

- (i) 01 (one) iron made sword measuring approx. 75 cm in length including butt which is found on the right hand of the accused person named Md. Sharukh (M/29 Yrs.) S/O Lt. Md. Mukim of Coila Depo, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling.
- (ii) 01 (one) iron made rod measuring approx. 70 cm in length which is found on the left hand of the accused named Md. Sahid (M/ 19 Yrs.) S/O Md. Hamid of Gowalapatty, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling.
- (iii) 01 (one) steel made pipe measuring approx. 83 cm in length which is found on the right hand of the accused Md. Jahangir (M/27 Yrs) S/O Lt. Javed Ali of Tikiapara, Ward No. 28 of SMC, P.S- Siliguri, Dist.- Darjeeling.
- (iv) 01 (one) iron made sword measuring approx. 75 cm in length including butt which is found on the right hand of the accused person named Bijay Barman (M/ 19 Yrs.) S/O Lt. Gautam Barman of Coila Depo, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling.
- (v) 01 (one) Iron made rod measuring approx 61 cm in length which is found on the right hand of the accused named Aman Paswan (M/ 19 Yrs.) S/O Kumar Paswan of FCI Gate, Ward No. 35 of SMC, P.S- NJP, Dist.- Jalpaiguri.

I ASI Majaffar Rahaman Mandal of Khalpara TOP-II under Siliguri PS, SPC do here by lodged this written complaint against the above noted accused persons and 6/7 others to the effect that on 09.05.2026 at 00.35 hrs., received a source information that approx 11/12 youths were assembled at Jhankar More, near abandoned field of Power House, Ward No 07 of SMC under Siliguri PS with a view to commit Dacoity in a Night Super Bus passes through Jhankar More. The fact has diarized in Khalpara TOP GDE No- 183 dated-09.05.2026. Subsequently, after sharing the information with my superiors and as per their direction, at 00.45 hrs. myself along with officers & forces of Khalpara TOP left for Jhankar More, near Power House, Ward No 07 of SMC under Siliguri PS to work out the information along with investigation kit to verify the veracity of the information vide Khalpara TOP GDE No- 184 Dated- 09.05.2026.

On the way to Jhankar More, I contacted with two independent witness namely Uttam Saha (56 Yrs) S/O Lt. Kalicharan Saha of Phansidewa, Jyotinagar, P.S- Phansidewa, Dist.- Darjeeling and make him aware about the information and requested him to act as witness, if any search and seizure would be made necessary upon which they agreed.

Thereafter, we along with the independent witness noted above reached at Jhankar More, near Power House, Ward No 07 of SMC under Siliguri PS at 01.05 hrs. and being pointed by the source cordoned off the suspected persons with strong reason to believe that they were preparing to commit some cognizable offence in our locality. Seeing the police personnel they tried to flee away but on hot chase we managed to apprehend above noted 05 (five) accused persons along with seized articles as mentioned above. However the other 6/7 persons manage to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a Night Super Bus passes through Jhankar More area under Siliguri Police Station.

I therefore, seized the above noted weapons under proper seizer list duly signed by the witnesses and acknowledged by the accused persons. The whole search and seizure was made in between 01.15 hrs. to 01.45 hrs. under proper video-graphy in presence of independent witnesses. Thereafter I arrested the above noted accused persons under proper memo of arrest duly signed by the accused persons.

On further interrogation the arrested accused persons stated that they were gathered there to commit dacoity in a Night Super Bus passes through Jhankar More area under Siliguri Police Station. It is also revealed from them that 6/7 other associates were managing to flee away from the spot taking the advantage of darkness.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused persons namely (i) Md. Sharukh (M/29 Yrs.) S/O Lt. Md. Mukim of Coila Depo, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling, (ii) Md. Sahid (M/ 19 Yrs.) S/O Md. Hamid of Gowalapatty, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling , (iii) Md. Jahangir (M/27 Yrs) S/O Lt. Javed Ali of Tikiapara, Ward No. 28 of SMC, P.S- Siliguri, Dist.- Darjeeling, (iv) Bijay Barman (M/ 19 Yrs.) S/O Lt. Gautam Barman of Coila Depo, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling and (v) Aman Paswan (M/ 19 Yrs.) S/O Kumar Paswan of FCI Gate, Ward No. 35 of SMC, P.S- NJP, Dist.- Jalpaiguri and others and arrange for its investigation.
