With due respect, I Shri Gourab Paul,  
s/o Shri Ganesh Chandra Paul, resident of - Vivekananda  
Nagar, Vivekananda Road, near Shankar More, Siliguri,  
ward No - VII, P.S. - Siliguri, Dist. Darjeeling would  
like to lodge this written complaint to the effect  
that today i.e. on 09/05/2026 at about 10:20 hours,  
when my father Shri Ganesh Chandra Paul, aged  
about 70 years while going to the market, and  
when he dropped from a toto vehicle near Rail gate,  
Mahabirasthan, he was physically assaulted by said  
toto driver on the plea of extort more money from  
him. Said toto driver also assaulted him on his face  
and nose and as a result of which, he sustains  
bleeding injury and also fallen on the road. Subsequent  
we gathered the name of the toto driver as Kaseem  
Considering the severe injury we brought my  
father to the Siliguri District Hospital where

the attending doctor treated him and also advised him to take complete bed rest.

I, therefore request you to investigate into the matter and please take strong legal steps against the said toto driver as per the provisions of law and obliged thereby.
