Respected Sir,

With due respect I, **SMT. SHIKHA GHOSH**, Wife of Late Subhash Chandra Ghosh, Daughter of Late Sudhir Chandra Ghosh, Resident of Rash Behari Sarani, Hakim Para, P.O. & P.S. Siliguri, Dist. Darjeeling, Pin: 734001, would like to lodge this Written Complaint before your authority to the effect that I am the absolute and exclusive owner of all that piece or parcel of one Shop Room measuring about 1440 Sq. Ft. (Super Build-up Area) situated in the Ground Floor (Front Side) of a Three Storied Building, popularly known as Ghosh Brothers Building, together with proportionate undivided share of land on which the building is standing measuring about 0.145 Acre, appertaining to and forming part of R.S. Plot No. 2207 corresponding to L.R. Plot No. 2041, recorded in Khatian No. 5482/1, situated within Mouza - Siliguri (presently Siliguri Purba), J.L. No. 110(88) (Old), 92 (New), Touzi No. 3(Ja), Pargana - Baikunthapur, situates within Ward No. 12 of Siliguri Municipal Corporation and the said Shop Room is located at Bidhan Road, P.O. & P.S. Siliguri, Dist. Darjeeling and I have acquired the said Shop Room by virtue of a Deed of Gift, executed by my three brothers namely Sri Shyamal Chandra Ghosh @ Shyamal Ghosh, Sri Sekhar Ghosh and Sri Subal Ghosh, on 27/03/2026 and the same was registered in the Office of the A.D.S.R. - Siliguri - I, Dist. Darjeeling, being Document No. I - 0686 for the year 2026 and since then, I have been possessing, occupying and enjoying the same in my actual, khas and physical possession, having right, title and interest therein, free from all encumbrances and charges whatsoever.

After acquiring the aforesaid property, I have started to renovation work in the said shop room and front portion of the said shop room is covered with rolling shutter. On 07.05.2026, in the morning, my adjacent shop owner of Kundu Brothers informed me over phone that some burnt smell is coming out from my said shop room and requested me to open the said shop to find out the actual reason of such smell and accordingly after receiving the said information, I went there and opened my shop and found that due to the short circuit, the smell is coming out and accordingly, I immediately informed the Electricity Department to verify the same. Thereafter, the Officials of the Electricity Department have visited my shop and cut out the wires and disconnected the

electric connection immediately. During the continuation of the said work, my brother-in-law Sri Sukumar Ghosh, his son namely Sri Gourav Ghosh and his wife Smt. Manju Ghosh, came there and started to abuse me and my daughter-in-law with abusive and slang languages and also threatened us as to why I opened the said shop room without their prior consent though they have no right over the said shop room and in reply, when I told them that I am the owner of the said shop room and I have every right to open and close the said shop as per my wish, they became more furious and snatched away the Keys of the shutter of the said shop room from my possession forcefully and also assaulted me by my brother-in-law and his son in conspiracy with Smt. Manju Ghosh and threatened us with dire consequences by saying that they will teach us a good lesson and put us behind the iron bar by making a false complaint against us. Sir, during that scenario, they have also tried to outrage my modesty as well as the modesty of my daughter-in-law and due to their said assault, I have received some injuries on my person and treated at Siliguri District Hospital. Sir, from their aforesaid acts and activities, it is clear that by hooks and crooks, they are trying to take the possession of my said shop room forcefully for their wrongful and illegal gain though it is very much within their knowledge that they have no right, title and interest over my said shop room. As the matter was in our family members, I tried to settle the disputes amicably but due to their adamant attitude and rude behaviour, the same could not be resolved for which some delay has been caused for lodging this written complaint.

I, therefore, fervently request you to enquire into the matter and please take appropriate legal action against Sri Sukumar Ghosh, his wife Smt. Manju Ghosh and their son namely Sri Gourav Ghosh as per the provision of law and oblige thereby.
