Sir,

This is to inform you that I, **SRI. MINTU CHANDRA DEY**, son of Late Jogesh Chandra Dey, aged about 70 years, resident of- Mukunda Das Road, near Loknath Grill Factory, New Millan Pally, Siliguri, P.O.- Siliguri Bazaar, P.S.- Siliguri, District- Darjeeling, PIN- 734005, would like to inform you that on 05.07.2025 at around 10:00 a.m., while I was reading the newspaper sitting at the dining table, my son namely Sri. Rajib Dey and his wife Smt. Sonali Dey came and started to quarrel with me and throw the utensils and other articles here and there and became very violent and started beating me and pressurizing me to leave my house to which I denied, but they gave me 10 days ultimatum to leave my house and left. Thereafter on 22.07.2025, my son and his wife again came to my room and again started pressurizing me the leave my house so that he can take over the entire house of mine and when I again denied, they threatened me with dire consequences *inter alia* stating that he will not let me stay alive till. Furthermore, on 04.08.2025, the ceiling fan in my room was malfunctioning and as such I had called the electrician for some repair works, however, my son came and threwed out/forcefully ousted the electricians and did not allow them to carry out the repair works *inter alia* stating that he has obtained injunction order from the court and no work will be carried out without any order from the learned court. It is pertinent to mention herein that due to such extreme weather conditions and the behaviour of my son, me and my wife is facing extreme difficulty in sustaining livelihood at my own house and such acts and conducts of my son and his wife are in contravention of the order passed by the Learned Court in Title Suit No. 73 of 2025, as I am being disturbed from the peaceful possession and enjoyment of my own property.

That my son and his wife is continuously torturing us both mentally and physically on a regular basis in all possible ways and is not allowing us to live peacefully even at our tender age and they are also not looking after and taking care of our basic needs which is a right given to every senior citizen under the statutes and upon being frustrated by such torture, I seek your help to protect me from such torture.

Under the aforesaid facts and circumstances, I, being an aged and an ailing senior citizen of this country, kindly request you to take appropriate action against my son Sri. Rajib Dey and his wife Smt. Sonali Dey, otherwise there will be great injustice to me.
