Sir,

With due respect, I, Mina Paswan, Wife of Biku Paswan, Resident of Tea Auction Road, Shiv Nagar, P.O. & P.S. Pradhan Nagar, Dist – Darjeeling, Pin- 734003, beg to inform you on 10/05/2026, at about 7.30 p.m., one Khusboo Chhetri and Prakash Chhetri, both are minor daughter and son of one Kali Chhetri had under her instigation, came to the Sabji Bazar at Darjeeling More and forcefully taken my minor daughter namely Manjita Paswan (aged about 14 years) to their house and forcefully confined her in their house. Being unable to find my daughter, I along with my other family members started searching for her. My family even went to the house of the said Kali Chhetri and asked if my daughter is therein, but they denied having any knowledge about the same. Later after constant searching, at about 10.30 p.m., we again went to their house and we asked them again, and seeing their reaction we along with local people got suspicious and entered their house and found our daughter inside and she was under immense fear and unable to speak and we take away our daughter from therein. The Said Kali Chhetri threatened us that if we try to take any legal action we shall face its consequences.

Today i.e. on 11/05/2026, at about 5 p.m. when my sister-in-law (debrani) namely Santoshi Paswan, Wife of Sri Bikram Paswan, went to drop her 4 years old daughter in private tuition, near the rail line, the said Kali Chhetri, her mother and her sisters taunted said Santoshi Paswan and used filthy unspeakable language towards her, but to avoid any conflict she ignored them and minded her own business. Unfortunately, at about 6 p.m., when my debrani namely Santoshi Paswan, was returning after pick up her daughter from private tuition and she also carrying her 1.5 years old son in her arms; the said Kali Chhetri, her mother and her 3 or 4 sisters stopped her in her way started beating her mercilessly without any rhyme or reason in her face, abdomen and every part of the body with a very intention to end her life and they were shouting that they will end her life today. The local people heard the hue and cry of my debrani namely Santoshi Paswan and rescued her from their hands. She was severely injured and has a bleeding nose; hence, she was taken to the Siliguri District Hospital for her treatment. Her 1.5 years infant son also sustained injury in his hand.

Today i.e. on 11/05/2026 at about 5.30 - 6 p.m., while I along with my mother-in-law, my daughter namely Manjita Paswan and our relative namely Rani Khatoon, went to the Pradhan Nagar Police Station to inform the incident happened yesterday, we came to know about the incident about the assault on Santoshi Paswan and started to return to our house in a hurry. My daughter namely Manjita Paswan and our relative namely Rani Khatoon were way ahead of us as they started running after hearing the incident. In the way near the Asam Rail gate the said Kali Chhetri, her sisters along with 2 unknown men in a drunken condition, wrongfully restrained my minor daughter namely Manjita Paswan and our relative namely Rani Khatoon, both 14 years old, and tried to forcefully tie the hands and mouth of the my minor daughter namely Manjita Paswan and our relative namely Rani Khatoon and even assaulted them by slapped in their face and threatened then that if they try to resist, they shall face dire consequences. We from far away saw the said incident and started shouting and running towards them, the said persons due to the said hue and cry became scared and ran away from there. If we haven't reached therein in time then they would have take both the minor children for their ulterior motive.

Me and my family are in constant fear as we are living our life in fear for our life and safety of children in our house from the hands of said miscreants. Therefore you are hereby requested to take proper legal action against the said Kali Chhetri, her mother and her sisters and two men in drunken condition who accompanied them and protects us from the said miscreants and oblige us.
