Subject: FIR

Sir,

I, MD. ALLAUDDIN, son of MD. Kafiluddin, resident of Santoshi Nagar, Ward No. 5 of S.M.C., P.O. - Siliguri Bazar, P.S. - Siliguri, Pin - 734005, Dist. - Darjeeling, West Bengal, would like to inform you that I have a shop at Tula Nagar, Kholai Baktri, P.O. & P.S. - Matigara, Pin - 734010, Dist. - Darjeeling. On the night of 06.05.2026, at around 10 to 10:30 PM, when I was returning to my residence as per my usual daily routine, I found around 40 to 50 persons waiting near Jyoti Nagar More, close to the 4th Mahananda Bridge. That as soon as I was passing through that site, I was unlawfully intercepted and surrounded by the alleged persons. The alleged persons formed an unlawful assembly and, in furtherance of their common intention and conspiracy, wrongfully restrained me and launched a brutal, violent, and premeditated physical assault upon me. The accused persons mercilessly attacked me with the clear intention to cause grievous injuries and to eliminate me physically. Some of them were wearing helmets, due to which I could not identify all of them. However, among them I could clearly identify:

1. Puja Mahato daughter of Late Jamun Mahato, residents of Kholai Baktri, P.O. & P.S. Matigara;
2. Amit Gupta, son of Kishori Gupta, resident of Tumba Jyot, Beldangi, P.O. & P.S. Matigara
3. Raja Gupta, son of Kishori Gupta, residents of Tumba Jyot, Beldangi, P.O. & P.S. Matigara;
4. Laxman Sahani @ Batha, son of Nantun Sahani;
5. Akash Roy, son of Babu Roy
6. Manoj Sah, son of not known, resident of Kholai Baktri, P.O. & P.S. Matigara;
7. Lalhabu Sah, son of not known, resident of Kholai Baktri, P.O. & P.S. Matigara;

The above-named persons wrongfully restrained me by blocking my path, and then forcefully took away the keys of my motorcycle bike. Thereafter, the person Puja Mahato and her associates above named abused me with filthy languages and told me: "Tu jo ye Sone ka Chain pehna hai, wo to Haram ka Paisa ka hai". Further, during the commission of the offence, the alleged Puja Mahato forcibly snatched away my gold chain weighing approximately 10 grams, which had been purchased by me in the year 2024, thereby committing robbery in the course of assault. Such was the intensity and ferocity of the assault and attack on me, that while I was getting beaten up, those miscreants took away three gold finger ring that I was wearing. (Photocopy of bill is hereby annexed with this FIR). It is further stated that I have the photographs and video clearly showing that Puja Mahato had snatched my gold chain (the photocopies of the incident capturing the brutal assault and the photo copy showing that I had the gold chain in my neck at the time of incident are attached with this FIR, for the perusal of your good office). Moreover, the person Laxman Sahani, forcefully took away Rs. 8,000/- (Rupees Eight Thousand) cash, which I had kept in my pocket. I further state with utmost anguish that the accused Puja Mahato intentionally humiliated and degraded me in public by spitting on the road and forcibly compelling me to taste the same against my will. Such conduct was not only inhuman and degrading but also intended to outrage my dignity and in still fear and humiliation.

Soon after this, all of them together ganged up upon me and launched a brutal and merciless assault upon me, along with the other unknown associates. They repeatedly assaulted me with fists, kicks and blows on my head and entire body with clear intention to cause grievous harm and endanger my life. The above-named persons and their other miscreant associates continued beating me mercilessly even after I fell on the ground and left me in a critically injured and half-dead condition on the roadside.

It is important to mention here that, the said Puja Mahato has preplanned the entire incident with intention to kill me. That I had received several comments targeting my religion and portraying myself to be aatankwadi jihadi, on my social media account like Instagram, facebook, and even verbal threats before this incident. (the photocopy of such screenshot is hereby annexed with this FIR for the perusal of your good office). I had received several death threats from her following which I had lodged one written complaint before your good office on 15/04/2026.

Due to the violent assault, I sustained severe injuries on my head and various other parts of my body and became physically helpless. The entire incident was deliberate, pre-planned and carried out with criminal intention by the accused persons acting together as an unlawful assembly. I also state that the accused persons acted with deep communal hatred and used abusive, provocative, and threatening conduct during the incident, thereby disturbing public peace and harmony.

Importantly, the entire occurrence and unlawful activities committed by the accused persons were recorded in a video, which I have subsequently managed to collect from a person present at the place of occurrence. The said video footage clearly reflects the violent acts and involvement of the accused persons, the said video footage is placed in a pen drive and is hereby attached with this FIR as an evidence.

After their brutal and ferocious attacks, some other local people rescued me and informed the Police. At this, I was taken to the Matigara Police Station and even there, they were waiting outside the Police Station and were threatening me with abusive languages. Thereafter, a fake case was lodged against me before the Matigara Police Station, by those miscreant themselves having numbered Matigara P.S. G.D.E. No. 288, dt. 07.05.2026, u/ Sec. 292 of BNS for which I was arrested and produced before the Learned Additional Chief Judicial Magistrate, at Siliguri and the Ld. Court granted bail in my favour.

The assault was extremely heinous and life-threatening in nature, as a result of which I sustained multiple injuries on various parts of my body and suffered severe vomiting, physical pain, mental trauma, humiliation, and emotional distress. I had been to the hospital as I was continuing the vomit and I was also admitted to Siliguri District Hospital and treated myself there for which I am late in submitting this FIR. I also suffered substantial loss and damage to my personal property during the course of the incident.

Therefore, I humbly request you to kindly treat this application as an FIR and take immediate strict legal action against all the accused persons under the relevant provisions of law, conduct a proper investigation and provide me justice.
