Sir,

With due respect and humble submission, I, SI Malay Kr. Roy of Matigara P.S /SPC do hereby lodge this written complaint to the effect that today on 09/05/2026, while performing K-32 van morning Duty along with Constable - 227- Samir Sarkar and Constable- 525 Hitendra Nath Roy vide MCC No- 1731 date- 09.05.26 and Matigara PS GDE No- 409 date- 09.05.26 in course of my mobile van., I received a source information that one tractor with trolley loaded with river bed materials was proceeding towards Matigara side after procuring the same clandestinely from Balasan river area.

On receipt of such information, I informed the matter to the I/C Matigara P.S and as per his kind direction myself along with force rushed to spot i.e Thana Road, Amtala under Matigara P.S and intercepted one tractor with trolley loaded with river bed materials. On demand, the driver of the said vehicle could not produce any valid document in respect of the loaded river bed materials, as well as vehicle relevant papers and driving licence.

It is crystal clear that the driver of the said tractor procured the river bed materials from somewhere clandestinely and was proceeding to sell the same to designated customers for wrongful gain. Accordingly, I seized one tractor with trolley loaded with river bed materials having Engine No.- NJD6CAJ0366 and Chassis No.- MBNADANBEJND04114 along with key under proper seizure list followed u/s 105 of BNSS from Thana Road, Amtala, Matigara.

I also arrested the driver namely Biswajit Barman (23 Yrs/Male), S/O- Pabitra Barman of Vill- Tarabari, Post- New Rangia, P.S.- Matigara, Dist.- Darjeeling on 09/05/2026 at 13:47 hrs and informed him the ground of arrest in written in presence of witness, and also informed his relatives. Thereafter, the seized vehicle was brought to Matigara P.S and kept at P.S compound and hand over to the malkhana dealing officer of Matigara PS the arrested accused was kept in P.S lock-up after maintaining proper Hazat rules alert the sentry duty as well as duty officer. The seizure was made in between 13:30 hrs to 13:45 hrs on 09/05/2026.

I therefore pray before you that a specific case under proper sections of law may kindly be registered against the accused driver namely Biswajit Barman (23 Yrs/Male), S/O- Pabitra Barman of Vill- Tarabari, Post- New Rangia, P.S.- Matigara, Dist.- Darjeeling and arrange for its investigation.
