

**APPREHENSION OF ~~SUSPECTED BANGLADESHI NATIONAL~~**

On 12 May 26 at approx. 1745h, the guard of Bengdubi Military Station alongwith cattle guard during routine surveillance and patrolling at ARF, Bengdubi, noticed a suspicious individual loitering near the area and attempting to enter the bogie of a Military Special Train parked at ARF Bengdubi Military Station.
2. The individual disclosed his identity as KAUSHIK BISWAS S/o Kisnu Biswas, aged approx 21 yrs. He further stated that he had run away from his maternal uncle's residence located at Sarkar Pada, North 24 Parganas (WB).
3. The individual was not in possession of any identification documents or mobile phone. However, he provided one mobile number 9749852549 which was found switched off.
4. The individual is being handed over to Bagdogra Police ~~under foreign act 1946~~ for futher necessary action and detailed verification.
