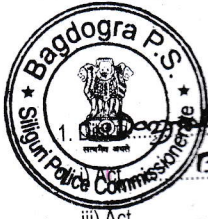

I, Smt. Roshni Sah Daughter of Late Kishori Sah, resident of Rupsing Jote, Gossainpur. P.O.- Ranidanga, P.S.- Bagdogra, Dist.- Darjeeling, PIN-734014. would like to lodge this complaint.

I came to contact with Manish Kumar Sharma Son of Kapil Deo Mistry, resident of House No.-23.Vill.- Ambari, Shekhupursarai, Sheikhpura, Bihar- 811103, who is presents residing in Varanasi along with his wife and other family members, who has disclosed himself as bachelor and thereafter he started to contacting with me and thereafter most illegally and unfortunately without my consent and completely keeping me in dark, said Manish Kumar Sharma has captured some my private moment photos, which are absolutely beyond my knowledge.

Sir, during conversation, I have checked his Mobile phone being No.- 7275862183, while shockingly and surprisingly, I have found that said Manish Kumar Sharma has illegally and wrongfully saved my nude photographs and videos in his mobile phone.

Sir, after coming Siliguri, said Manish Kumar Sharma under the threat of viral my nude videos and photographs, forced me to sexual intercourse with him and absolutely without my consent he has raped me on several times against my consent and willingness

Sir, on enquiry I have also come to know that said Manish Kumar Sharma is one of the gang leader who used to blackmail to the women under the shield of friendship and thereafter they used to demand monies forcefully and coercively from the innocent women like me and they also cheated the people in this way with an dishonest intension deceivably.

Sir, now I have come to learn that he has married man and he has his own wife and daughter.

I, therefore, humbly pray with you to take immediate drastic legal actions against said Manish Kumar Sharma, Son of Kapil Deo Mistry, resident of House No.- 23. Vill.- Ambari Shekhupursara i, Sheikhpura, Bihar- 811103, in accordance with law and your good and urgent cooperation is very much expected in this regard.
