I, Sri Tapas Bishui, Divisional Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Dheeraj Kumar, (Ph No.-9749371208), S/o- Khublal Paswan, Secretary, Kiran Sangha Club, Bagrakote Near-Shiv Mandir, Ward No-18 Siliguri, Dist-Darjeeling-734001 for having committed offence as stated here under.

On 12.05.2026 at about 12.09 p.m. acting on a source information I, along with (1) Sri Bijay Lakra, S.E., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the premises (Kiran Sangha Club) of Sri Dheeraj Kumar, Secretary and inspected service and metering installation of Consumer ID **400574693** in the name of Sri Dheeraj Kumar, Secretary. During inspection it was found that electricity was being used unauthorisedly & illegally by Dheeraj Kumar by reconnecting the deemed disconnected service line of the metering installation that was disconnected previously on 26.12.2023 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the deemed disconnected service line and metering installation was detected the energy meter make HPL-SOCOMEK Pvt Ltd, serial no.- **P2106457** installed against Con Id. **400574693** seized by preparing a formal seizure list duly signed by Dheeraj Kumar, Secretary and witnesses. The copy of the seizure list handed over to Dheeraj Kumar and his signature obtained as token of receipt.

As Dheeraj Kumar, Secretary have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the deemed disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR.
