Sir,

In producing herewith the following accused person namely Raju Sharma (41 yrs) S/O Late Mohon Prasad Sharma of Jaduvita, Milan More, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure viz :- (i) 01 (one) red colour Goods Carrier (Tractor) having Registration No. WB/73/G/2573 loaded with illegal river bed materials along with Key under proper seizure list. I, ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the the above noted arrested accused person namely Raju Sharma (41 yrs) S/O Late Mohon Prasad Sharma of Jaduvita, Milan More, PS- Pradhan Nagar, Dist. Darjeeling and the owner of the said seized vehicle having Registration number WB/73/G/2573 to the effect that on 13.05.2026 at 05.30 hrs I received specific source information that the driver with the assistance of vehicle owner having registration No WB/73/G/2573 are mining river bed materials at Mahandnda river bed, Military Ghat near Bou Bazar and loaded illegally mained river bed materials in the Tractor having registration number WB/73/G/2573. Accordingly, I noted the fact in PS General diary vide Pradhan Nagar PS GDE No 669 dated 13.05.26 and informed the fact to you. As per your kind order and direction myself along with force left for Military Ghat of Mahananda river to verify the veracity of the information. At around 05.55 hrs we reached at near Military ghat near Bou Bazar and found one tractor loaded with river bed materials is coming towards Samar Nagar side. Accordingly, we detained the tractor having registration No WB/73/G/2573 loaded with river bed meterials and also detained the driver of the said vehicle. Thereafter, we disclosed our identities as Police personnel (as 4/5 police personnel of our team were in civil dress for our convenience). On interrogation the driver of the said vehicle disclosed his identity as noted above. On demand he failed to produce any valid documents in respect of illegal river bed materials loaded in his vehicle. On further interrogation he disclosed that he with the help of his owner mines such river bed materials from Mahananda River by illegal means with a view to sale the same to their design customers for their illegal gain. Accordingly, I seized the above noted vehicle having registration number WB/73/G/2573 loaded with illegally mining river bed materials under proper seizure list and subsequently arrested the said detain driver of the said vehicle after maintaining all the formalities of arrest and brought to Pradhan Nagar PS for further investigation. The search and seizure was made in between 06.35 hrs. to 07.15 hrs. at the spot under the coverage of videography as per norms of BNSS. I issued copy of Memo of arrest and ground of arrest in written to the him. Further I informed the wife namely Maya Sharma regarding arrest of Raju Sharma and also informed her that accused Raju Sharma is being forwarded before Ld Court today at around 11.00 hrs.

Under the above noted fact and circumstances, I therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Raju Sharma (41 yrs) S/O Late Mohon Prasad Sharma of Jaduvita, Milan More, PS- Pradhan Nagar, Dist. Darjeeling and the owner of the said seized vehicle having Registration number WB/73/G/2573 and arrange for its investigation.
