Sir,

In producing herewith following seized articles as per seizure list viz :- (i) One blue and maroon colour goods carrier vehicle (Truck) having Registration No WB/73/B/9099 loaded with illegally mined river bed materials and (ii) one orange colour goods carrier vehicle (Truck) having Registrtrtion No WB/76/0695 loaded with illegally mined river bed materials.


I, ASI Bikash Roy of Pradhan Nagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the driver and owner of the following two seized vehicles having registration number (i) WB/73/B/9099 and (ii) WB/76/0695 to the effect that on 13.05.2026 at 05.20 hrs I received secret source information that two Trucks having registration No. (i) WB/73/B/9099 and (ii) WB/76/0695 loaded with illegally mined river bed materials are coming towards Champasari side from Mahananda river bed, Military Ghat and the said both the trucks will go to their destination via Jamai Bazar area. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 670 dated 13.05.26 and informed the fact to you. As per your kind order and direction myself along with force left for Samar Nagar Jamai Bazar under PS- Pradhan Nagar, Dist. Darjeeling by Got vehicle to verify the veracity of the information vide Pradhan Nagar PS GDE No 670 dated 13.05.26. At around 05.45 hrs we reached at Jamai Bazar under PS- Pradhan Nagr, Dist. Darjeeling and from a considerable distance we noticed that two trucks lodaded with rived bed materials were coming towards Champasari side. Accordingly, we proceeding towards both the said trucks but seeing the Police van the drivers of the both trucks stopped their vehicle on the road and managed to flee away from the spot. We tried to apprehend them but in vain. After physical verification it is found that both the said trucks having Registration number (i) WB/73/B/9099 and (ii) WB/76/0695 are loaded with illegally mined river bed materials. I searched the driver and owner of the both trucks but nobody could able to provide any information regarding driver and owner of the trucks. During local enquiry it could be revealed that the driver and owner of the both the vehicle having Regn No (i) WB/73/B/9099 and (ii) WB/76/0695 mines such illegal river bed materials from Military Ghat of Mahananda River illegally and loaded the same in their vehicle having Registration Number (i) WB/73/B/9099 and (ii) WB/76/0695 with a views to sale the same to their designed customers for their illegal gain. Accordingly, I seized the said detained both the trucks having Registrtrtion Number (i) WB/73/B/9099 and (ii) WB/76/0695 loaded with illegally mined river bed materials under proper seizure list in presence of witnesses at the spot and brought to Pradhan Nagar PS for further investigation. The seizure was mede in between 07.15 hrs to 07.50 hrs under the video coverage of vediography as per norms of BNSS.

Under the above circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the drivers and owners of the vehicle bearing registration number (i) WB/73/B/9099 and (ii) WB/76/0695 and arrange for its investigation.
