Sir,

In producing herewith four (04) accused persons namely (i) Haradhan Karmakar (32 yrs) S/O Late Bimal Karmakar of Pati colony, Road No-02, PS- Pradhan Nagar, Dist. Darjeeling (ii) Md Mojabil (28 yrs) S/O Md Atabul of New Pokai jote, PS- Pradhan Nagar, Dist. Darjeeling (iii) Suraj Paswan (26 yrs) S/O Sandip Paswan of Naya Bazar, Dakshin Palash, PS- Pradhan Nagar, Dist. Darjeeling and (iv) Rahul Paswan (23 yrs) S/O Sandip Paswan of Naya Bazar, Dakshin Palash, PS- Pradhan Nagar, Dist. Darjeeling under arrest along with the following seizure articles viz :- (i) one sharp cutting weapon locally called as Hasua measuring approx 25 inches in length including its wooden butt (ii) one sharp cutting weapon locally as Hasua measuring approx 22 inches in lenth including its wooden butt (iii) one iron made sabol measuring 22 inches in length (iv) one sharp cutting weapon locally called as Drigger measuring approx 16 inches in length including its wooden butt and (v) one blue colour torch light (vi) one iron made hammer and (vi) one multi colour nylin bag. I, ASI Md Anwar Abedin of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted four (04) arrested accused persons and others 07/08 unknown miscreants who involve in this crime, to the effect that on 14.05.26 at 00.35 hrs I received a specific source information that about 11/12 miscreants equipped deadly weapons assembled in an abandon Rly Quarter at B.R.I. Colony under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at Gate Bazar area. Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 739 dated 14.05.26 and informed the matter to you. As per your kind order and direction, I along with ASI Biplab Kr Das, ASI Prabal Sarkar, C/1119 Tanmoy Roy and force all of Pradhan Nagar PS, SPC left for Gate Bazar under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed night RT van officer ASI Julfikar Hussain and requested him to come to BRI Colony to accompany with us.

At around 00.55 hrs we arrived at BRI Colony under PS Pradhan Nagar, Dist. Darjeeling and after a while night RT van officer ASI Julfikar Hussain arrived there and accompanied with us. I shared the information with them and briefed them properly. Thereafter, I requested two independent witnesses namely (i) Rabindra Sharma (25) S/O Shivnath Sharma of Gurung Busty near Buddha Mandir, P.S. Pradhan Nagar, Dist. Darjeeling and (ii) Arjun Das (19) S/O Madan Das of Anchal near Kalibari, P.S. Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present at the spot and act as witness if any search and seizure would me made, upon which they agreed and expressed their willingness to co operate with me and act as independent witnesses. Then, I contacted my source and from a considerable distance he pointed to the place where the miscreants were assembled.

Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance. We noticed that 11/12 persons were assembled in an abandon Railway Quarter, BRI Colony under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching towards them, they tried to flee away from the spot but on hot chase we managed to apprehended above noted four (04) accused persons while 07/08 others unknown miscreants managed to flee away from the broken window taking the advantage darkness. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search the above noted weapon of offence are recovered from their joint possession which they kept concealed inside one multi color nylon bag. On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 07/08 of their associates assembled there and were making preparations for committing Dacoity at BRI Colony and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 01.15 hrs. to 01.45 hrs. at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed regarding ground of their arrest.

The entire process of search and seizure were made under the coverage of videography as per norms of BNSS through E-Sakshya Apps and brought all the four (04) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted four (04) accused persons along with 07/08 of their associates who fled away, gathered there equipped with deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Gate Bazar. Later, I informed their guardian regarding arrest of four accused persons and also informed them that all the four arrested accused persons will be forwarded before Ld ACJM, Siliguri on 14.05.26 morning at 11.00 hrs

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted four (04) arrested accused persons namely (i) Haradhan Karmakar (32 yrs) S/O Late Bimal Karmakar of Pati colony, Road No-02, PS- Pradhan Nagar, Dist. Darjeeling (ii) Md Mojabil (28 yrs) S/O Md Atabul of New Pokai jote, PS- Pradhan Nagar, Dist. Darjeeling (iii) Suraj Paswan (26 yrs) S/O Sandip Paswan of Naya Bazar, Dakshin Palash, PS- Pradhan Nagar, Dist. Darjeeling and (iv) Rahul Paswan (23 yrs) S/O Sandip Paswan of Naya Bazar, Dakshin Palash, PS- Pradhan Nagar, Dist. Darjeeling and others 07/08 unknown miscreants who fled away from the spot and arranged for its investigation.
