Sir,

I, PSI Sahanur Rahaman S/o Habibar Rahaman of Bhaktinagar P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against the arrested accused persons namely; (1) Sanjay Biswas (22 yrs) S/O Sri Anup Biswas of Kholachand Fafri, near Durga Mandir, PS- Bhaktinagar, Dist- Jalpaiguri (2) Binod Prodhan (32 yrs) S/O Late Raju Prodhan of Debidanga ,2nd Bridge, PS- Pradhan Nagar, Dist- Darjeeling (3) Roni Das (22 yrs) S/O Sri Dhaniram Das of Samar Nagar, near Auto Stand, PS- Pradhan Nagar, Dist- Darjeeling (4) Raju Singha (25) S/O Sri Mahendra Singha of Dadabhai Colony, Limbu Busty, Ward No.42, PS- Bhaktinagar, Dist- Jalpaiguri and (5) Bijay Mahato (34) S/O Sriram Mahato of Vivekananda Nagar, Ward No.42, PS- Bhaktinagar, Dist- jalpaiguri under arrest along with following seizure articles; (i) One iron made rod curb in front side measuring approx 18 inches , recovered from the possession of Sanjay Biswas (which was on his hand) (ii) One Iron made Hammer with bamboo handle measuring 15 Inches, recovered from the possession of Binod Prodhan (it was on his hand) iii) One Iron made screw driver measuring approx 09 Inches, recovered from the possession of Roni Das (iv) One iron made Haksaw blade measuring approx 11 inches recovered from the possession of Raju Singha (it was on his hand) and (v) one iron made Knief with wooden handle measuring approx 10.5 inches recovered from the possession of Bijay Mahato (it was on his hand). In this regard, I beg to report that on 14.05.26 at 00.35 hrs received secret reliable source information that about 10/12 anti socials being armed with deadly weapons assembled at near Abandon Swimming Pool, ward no. 42 under Bhaktinagar PS for making preparation to commit dacoity in a house at Limboo busty area under Bhaktinagar PS. I informed this source information to I/C Bhaktinagar PS and noted the information vide Bhaktinagar PS GDE No. 1583 Dated 14.05.26. As per the direction of I/C Bhaktinagar PS, at 00.45 hrs, I along with SI Youel Lepcha , ASI Dhruva Mishra, ASI Sadhan Roy, C/828 Dilip Ch. Barman, C/374 Debraj Biswas, HG-1589 Shivnath Adhikary along with investigation Kids left for near Abandon Swimming Pool, ward no. 42 under Bhaktinagar PS for working out the information vide Bhaktinagar GDE No. 1584 Dated 10.03.26 after briefing officers and force properly. At 00.55 around hrs we reached at near Abandon Swimming Pool, ward no. 42 under Bhaktinagar PS and kept our vehicle at considerable distance near Abandon Swimming Pool, ward no. 42 under Bhaktinagar PS. Then, I along with other Officers and force headed towards near Abandon Swimming Pool, ward no. 42 under Bhaktinagar PS looking for witnesses, if any on the way and found nothing. By this time we reached at near Abandon Swimming Pool, ward no. 42 under Bhaktinagar PS, as informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted five persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with 05/07 others assembled at the spot making


at Limboo busy area under Bhaktinagar PS. I accordingly searched them in presence of witnesses and found (i) One Iron made rod curb in front side measuring approx 18 Inches, recovered from the possession of Sanjay Biswas (which was on his hand) (ii) One Iron made Hammer with bamboo handle measuring 15 Inches, recovered from the possession of Binod Prodhan (it was on his hand) iii) One Iron made screw driver measuring approx 09 Inches, recovered from the possession of Roni Das (iv) One iron made Haksaw blade measuring approx 11 Inches recovered from the possession of Raju Singha (it was on his hand) and (v) one iron made Knief with wooden handle measuring approx 10.5 inches recovered from the possession of Bijay Mahato (it was on his hand) were making preparation for committing Dacoity tonight in a house at Limboo busy area but others managed to escape from the spot. Accordingly, I seized above noted weapons in presence of witnesses under proper seizure list duly signed by them and labeled the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure and label was made in between 01.25 hrs and 02.45 hrs dated 14.05.26. The whole search, seizure and label were made under Videography. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in a house at Limbu busy area, but others managed to escape from the spot.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity in a house at Limboo busy area under Bhaktingar PS.

Therefore, I pray before you to start a specific case against the above noted arrested accused persons and others 05/07 others who fled away, under proper section of law and to cause its investigation.
