SUB: FIR AGAINST RIVAN LAMA, PRAVESH CHHETRI,
NORGILA TAMANG, and 8-10 OTHERS UNKNOWN PERSON

I, Satish Chandra Rai s/o Sri Dil Chandra Rai

Siliguri P.O. Champasari P.S. Pradham Nagar Dist: Darjeeling
Pin: 754003 would like to lodge this complaint against
Rivan Lama, Pravesh Chhetri, Miss Norgila Tamang and
D/o Suresh Tamang and 8 to 10 others unknown person
Whose details are not known to me but can be
Identify by me.

The case in a gist is that on 01/05/2026 I along
my friends namely Sri Bijay Pradhan s/o finishing
our dinner at Club Gravity situated at city Centre Siliguri
came to the parking lot to take my car at around 2:00 am
at the juncture we both were blocked by two vehicle belonging
to the accused person when I requested them to leave
the way and allow us to go Rivan Lama along with
Pravesh Chhetri all of a sudden turned very furious and violent
and started to abuse us in filthy languages. upon hearing
the same we still request them to not to use filthy
languages and allow us to go. Rivan Lama, Pravesh Chhetri
Chhetri, Miss Norgila Tamang and 8 to 10 others unknown
person accompanying them were all under the influence
of alcohol thereafter all the other person started
shouting to kill us and Miss Norgila Tamang instigated
Rivan Lama to take out the knife from the vehicle upon
hearing the same Rivan Lama suddenly took out the
knife from his vehicle and rushed towards me
with an intention to kill me and hit me with a
knife. I at that moment raised my head but
unfortunately was hit

the knife in my ears while trying to save my self.

Since we were only two, and they were 12- to 15 person, all of them started hitting us mercilessly with fists and blows. In the said attack I suffered serious injuries and my medical document would prove the same. We somehow escape and fled from the said situation. Next day it came to our knowledge that a case has been filed against us by miss Norgita Tamang being Matigara P.S. Case No: 118/2026 dated 01.05.2026. The said case is absolutely false with a self manufactured story.

The deadly caused in lodging this instant complaint is that since we were implicated in a false case, we had been looking for legal resources to obtain bail from the L.D. Session Judge, Darjeeling which was rejected. There after we filed anticipatory bail before the hon'ble Calcutta High Court, Circuit Bench at Jalpaiguri being CRM (A) 252 of 2026 and vide order dated 27.04.2026 we were granted anticipatory bail by the hon'ble Calcutta High Court, circuit bench at Jalpaiguri. After our anticipatory bail we surrendered before the court of the learned Additional Chief Judicial Magistrate, at Siliguri on 30.04.2026

Thus it was only after our bail that we got legal guidance and thus I decided to file this instant complaint against the above named 3 person and 8-10 unknown person for physically abusing assaulting us with a knife and trying to kill us. I also anticipate that the entire incident is recorded in the CCTV camera installed in the parking lot of city Centre. The truth can be unearthed if the said CCTV footage are checked and preserved.

therefore requested you to Investigate the matter
and book the culprits namely Riyan Lama, Prakash
Chhetri, Miss Norgita Tamang, D/o Suresh Tamang
and 8 to 10 other unknown persons in accordance
with the appropriate provision of criminal law
and oblige.
