With due respect, I am producing herewith the 05 (five) arrested accused persons namely 1] Sonu Subba @ Kancha (21 years approx), S/O- Lt. Som Subba of Tindharia Chunbhati, PS- Kurseong, Dist- Darjeeling, 2] Md. Bilal (40 years approx), S/O- Lt. Md. Borjahan of Matigara Railgate, Biswas Colony PO+PS- Matigara, Dist- Darjeeling, 3] Abshiek Thapa (21 years approx), S/O- Kumar Thapa of Chowrasta Tungsung, PO+PS- Sadar, Dist- Darjeeling 4] Md. Tuku (24 years approx), S/O- Md. Hasu of Simultala, Baba Loknath Colony, PO+PS- Matigara, Dist- Darjeeling 5] Joy Biswas (23 years approx), S/O- Lt. Ratan Biswas of C/O-Md. Naju Alam Busty, Near Railgate, PO+PS- Matigara, Dist- Darjeeling and the following articles under seizure :-

1. One Iron made Sabol measuring approximately 3 feet from the possession of accused named Sonu Subba @ Kancha.
2. One Hacksaw blade from the possession of accused named Md. Bilal.
3. One iron made khuria measuring approximately 2 feet from the possession of accused named Abshiek Thapa.
4. One iron made plus from the possession of accused named Md. Tuku.
5. One torch light from the possession of accused named Joy Biswas.

I, ASI Bikash Roy of Matigara PS, Siliguri Police Commissionerate beg to state that on 12.05.2026 at about 23.25 hrs, I received a secret source information that a gang of miscreants were assembled at Paribahan nagar parking area, PS- Matigara, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Himachal Vihar area, under Matigara PS. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI Dipak Kr. Chhetri, ASI Prabir Karmakar, C/868 Sujal Roy, C/523 Sanjit Kundu and C/219 Sanatan Chitrakar all are of Matigara PS, Siliguri Police Commissionerate left for Paribahan nagar parking under Matigara PS to work out the information in hand. At about 23.45 hrs on 12.05.2026 we arrived at Paribahan Nagar Parking under Matigara PS in a vacant tin shed. After arrival of the spot and as identified by the source we found that 08/10 persons were assembled in a dark place i.e vacant tin shed at Paribahan Nagar Parking, PS- Matigara, Dist- Darjeeling and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended five (05) persons of them. On interrogation the apprehended accused persons, they disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there to commit dacoity at Himachal Vihar area under Matigara PS. They also stated that others 4/6 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 05

(five) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made on 13.05.2026 in between 00.15 hrs to 00.52 hrs. The whole process of seizure was made under videography and the video was made through WB E-Sakhya Application.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely 1] Sonu Subba @ Kancha (21yars approx), S/O- Lt. Som Subba of Tindharia Chunbhati, PS- Kurseong, Dist- Darjeeling, 2] Md. Bilal (40 years approx), S/O- Lt. Md. Borjahan of Matigara Railgate, Biswas Colony PO+PS- Matigara, Dist- Darjeeling, 3] Abshiek Thapa (21 years approx), S/O- Kumar Thapa of Chowrasta Tungsung, PO+PS- Sadar, Dist- Darjeeling 4] Md. Tuku (24 years approx), S/O- Md. Hasu of Simultala, Baba Loknath Colony, PO+PS- Matigara, Dist- Darjeeling 5] Joy Biswas (23 years approx), S/O- Lt. Ratan Biswas of C/O-Md. Naju Alam Busty, Near Railgate, PO+PS- Matigara, Dist- Darjeeling and others and arrange for its investigation.
