Sir,

With due respect and humble submission I ASI Chandan Chakraborty of Matigara P.S do hereby lodge this written complaint to the effect that today on 13/05/2026 I was deputed to perform special Mobile Van duty along with force, since 14:00 hrs to 22:00 hrs. vide Matigara P.S. M.C.C. No. 1760/2026, Dated- 13.05.2026 and Matigara P.S. GDE No. 645, Dated- 13.05.2026. In course of said mobile van duty I received source information that one EICHER Truck is standing at Simultala More under Matigara P.S loaded with river bed material which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara P.S over phone and as per his kind direction myself along with forces rushed at Simultala More under P.S.- Matigara and found one EICHER Truck bearing Regn. No. WB73 H 1353 loaded with river bed materials standing at Simultala More. On seeing the Police team the driver of the vehicle managed to flee away but somehow we apprehended him. On demand he could not produce any valid documents in support of said river bed materials. It is crystal clear that the driver/owner of the vehicle EICHER Truck bearing Regn. No. WB73 H 1353 procured the loaded river bed materials from somewhere clandestinely and was proceeding to sale the same to their designated customer for their wrongful gain.

Finding no other alternatives, I seized the said vehicle EICHER Truck bearing Regn. No. WB73 H 1353 loaded with river bed materials under proper Seizure List under coverage of Videography also brought the seized vehicle at P.S and arrested the driver namely, Raju Thami (32 Yrs/Male), S/O. Sundar Prakash Thami of Vill- Prasanti Gram, P.S. Sonada, Dist. Darjeeling. The seizure was made in between 15:25 hrs. to 15:40 hrs. on 13.05.2026.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver/ owner of the seized EICHER Truck bearing Regn. No. WB73 H 1353 and arrange for its investigation.
