Sir

In producing here with two arrested accused persons namely (1) Suraj Rai-29yrs s/o Sombahadur Rai of Gazing Power colony, PS Gazing, Dist West Sikkim and (2) Rakesh Rai @ Ayub @ Spyderman - 38yrs s/o Lt Hasta Bahadur Rai of Gazing, Power house colony, PS Gazing, Dist West Sikkim along with seizer articles i.e.

- (1) One Black colour Sony DSLR camera, Model No-SLT-A35 with Sony camera leans Model No-SAL1855 Made in Thailand with battery and memory card.
- (2) One Sony camera leans Model-SAL55300 (Made in China)
- (3) One SEIKO golden colour wrist watch, (Made in Japan)
- (4) One black colour camera bag, SONY written in outside the bag.

I SI Srimanta Chatterjee S/o Lt Debi Prasad Chatterjee of Matigara Police station under Siliguri Police Commissionerate lodged this written complaint against the above mentioned persons. I beg to report that on 13.05.26 at about 20.15 hrs received secret source information from opposite city center, NH-10 that two unknown boys have been roaming around in that area with the intention of selling a DSLR camera which appears to be stolen. Their behavior and activities seem suspicious, and they are approaching different people to sell the camera at a very low price. This matter may be related to theft or other illegal activities to selling the same for their wrongful gain.

Accordingly the information was diarized vide Matigara PS GDE No. 664 Dtd. 13.05.26 and informed to the I/C Matigara PS/SPC about this information. As per kind order of I/C Matigara PS/SPC myself along with ASI Dipak Chhetri, ASI Chandra Prakash Adhikary, ASI Prabir Karmakar, C/523 Sanjit Kundu, C/868 Sujal Roy , all of Matigara PS/SPC left PS to verify the veracity of information in c/w Matigara PS GDE No-665 dated 13.05.26. Myself along with force reached at the PO and detain two guys and as per showing and identified of my source found one black colour camera bag with them. On asking they disclosed their name and address as noted above and made some incoherent talks and became perplex. Then I opened the bag and found one DSLR Camera and one wrist watch which were kept inside the bag. On demand they failed to give any documents in respect of the by cycles. On being questioned they could not give any satisfactory account, moreover they made some contradictory statement which is reason to believe that they procured the camera fraudulent means or stolen from Gazing Taxi stand, Sikkim. Hence I seized (1) One Black colour Sony DSLR camera, Model No-SLT-A35 with Sony camera leans Model

No-SAL1855 Made in Thailand with battery and memory card. (2) One Sony camera lens Model SAL55300 Made in China. (3) One SEIKO golden colour wrist watch, Made in Japan (4) One black colour camera bag, SONY written in outside the bag in presence of witness from the possession of accused Rakesh Rai @ Ayub @ Spyderman - 38yrs s/o Lt Hasta Bahadur Rai of Gazing, Power house colony, PS Gazing, Dist West Sikkim after preparing proper seizure list in presence of witnesses (1) Sumit Dutta (Ph-8016866462) s/o Dilip Dutta of Tumbajote, Opposite Gas agency, PS Matigara Dist Darjeeling and (2) Sandip Paul (Ph-8167507057) s/o Saroj Paul of Ramkrishnanagar ward no-47 PS Pradhannagar Dist Darjeeling. The seizure process has been duly videographed. The whole process of seizure was made in between 20.50hrs to 21.30 hrs. Then I arrested them u/s 35 BNSS after issuing proper arrest memo with ground of arrest in written. During interrogation they admitted that on 12.05.26 they have stolen the same from Gazing Taxi stand and came at Siliguri to sell the camera at a very low price.

I therefore pray that a specific case may kindly be started against accused persons namely (1) Suraj Rai-29yrs s/o Som Bahadur Rai of Gazing Power colony, PS Gazing, Dist West Sikkim and (2) Rakesh Rai @ Ayub @ Spyder - 38yrs s/o Lt Hasta Bahadur Rai of Gazing, PS Gazing, Power house colony Dist West Sikkim under proper section of law and arrange for its investigation.
