Subject: FIR regarding cheating, impersonation as police officers, and theft of gold jewellery

Respected Sir/Madam,

I, Smt. Champa Paul, resident of Pradhan Nagar, Ward No. 3, Siliguri, would like to lodge a complaint regarding an incident of cheating, impersonation, and theft that occurred today morning.

Today, I had gone to drop my granddaughter at school. At around 11:30 AM, while I was returning to my residence, four unknown men suddenly approached me and blocked my path. They introduced themselves as police officers in civil dress and started questioning me regarding the gold jewellery I was wearing.

They falsely claimed that the Prime Minister had advised women not to wear gold jewellery in public, and further threatened me by saying that if I failed to comply, I would be penalized with a fine of Rs. 10,0000/-. Being an elderly woman, I became extremely confused, frightened, and mentally disturbed due to their intimidating behaviour.

Thereafter, they forcefully instructed me to remove all my gold ornaments. Out of fear and under pressure, I complied. The ornaments taken from me include:

1. Two (02) gold bangles
2. One (01) gold chain with locket
3. One (01) gold ring

As my bangles were difficult to remove from my hands, the accused persons even provided me with oil to facilitate their removal. After collecting all my jewellery, they packed the ornaments in a packet in front of me. However, without my knowledge, they secretly exchanged the original packet with a fake one and handed it back to me. Soon after, they fled the place.

I therefore request you to kindly register an FIR immediately, conduct a thorough investigation, identify and apprehend the accused persons, and recover my stolen gold ornaments at the earliest. Necessary legal action may kindly be taken against the offenders under appropriate sections of law.
