Respected Sir,

I, Smt. Baishaki Singh, wife of Ashiq Mandal, daughter of Sri Ratnesh Singh, presently residing at South Plus, P.S. Pradhan Nagar, Dist. Darjeeling, most respectfully beg to state that my marriage with Ashiq Mandal, S/O Late Salim Mandal, was solemnized on 12th June, 2025 according to Muslim rites and customs in the presence of relatives and well-wishers, though the marriage had been registered earlier on 16/05/2025. Before the marriage, my husband and his family members demanded Rs. 5,00,000/- along with gold ornaments and other articles as dowry. Under pressure and in good faith, my family somehow fulfilled their demands by giving Rs. 5 lakhs along with ornaments including Jhumka, Necklace, Mantika, Mehedi Chala, Payel, bridegroom ring etc. worth nearly Rs. 4 lakhs. However, on the very day of marriage, my husband Ashiq Mandal and his mother Noorbanu Khatun suddenly started demanding Rs. 20,00,000/- instead of Rs. 5 lakhs and began humiliating me and my family members over money. After I went to my matrimonial house situated near Football Ground, Darjeeling More, Dagapur, Siliguri, the torture upon me became unbearable. My husband and his mother continuously assaulted me physically and mentally regarding their unlawful monetary demands. They also forcefully took and sold my ornaments without my consent. I was regularly abused in filthy language, threatened with death and repeatedly told that unless I brought more money from my parental home, I would not be accepted in their family. As this was an interfaith marriage, I was also subjected to continuous mental cruelty regarding my personal beliefs and way of life. I was repeatedly forced and pressurized to follow religious practices against my will and was humiliated and assaulted whenever I expressed discomfort. They further used such issues as a means to wrongfully fulfill their monetary greed. My husband is extremely aggressive in nature and often behaved violently. He repeatedly pressured me to force my parents to transfer my share in paternal property and assets in his favour. Whenever I expressed inability, he abused and threatened me. He also kept obscene photographs and videos of mine without my consent and repeatedly threatened to circulate the same on social media and among relatives if his demands were not fulfilled. Due to such

continuous torture, humiliation and fear, I became mentally shattered and even had thoughts of ending my life. One person namely Tahinoor Islam, who frequently visited the matrimonial house and appears to be closely associated with their family, also behaved improperly with me. He used filthy language, intentionally touched me inappropriately and once grabbed me with ill intention while making obscene proposals. Whenever I protested or informed my husband and his family members, instead of protecting me, they assaulted and further harassed me. Even the sister of my husband namely Salima Khatoon physically assaulted and abused me along with the other accused persons. Thereafter, in the month of March, 2026, despite my unwillingness, my husband forcibly administered medicines/pills upon me and intentionally caused termination of my pregnancy against my will because I failed to fulfill his unlawful monetary demands. After consuming the pills, my health deteriorated badly and I started excessive bleeding, yet the accused persons did not take me to any proper doctor or hospital and instead arranged treatment through an unprofessional person at home, completely neglecting my health and safety. On 10th May at night, my husband again demanded money from me and when I refused, he violently assaulted me. He forcefully grabbed my neck and with an intention to kill me, strangulate me and also hit my hand with utensils causing severe pain and injuries. Somehow I managed to escape and informed my mother Dolly Singh. When my mother came to rescue me, the accused persons humiliated us and drove me out of the matrimonial house. Due to the continuous physical and mental torture, threats, humiliation and violence upon me, I remained terrified, emotionally disturbed and fearful that is why I could not file the complaint on that date. I am finally lodging this complaint today seeking protection and justice.

That I genuinely apprehend danger to my life, safety and modesty as well as to the lives of my family members. Therefore, I most humbly request you to kindly look into this matter with immediate effect and take immediate and strict legal action against the accused persons.
